LETTER FROM THE KWN CHAIR OF THE BOARD

Dear KWN members and staff,

We are leaving behind another successful year. The needs and interests of women and girls are naturally variable and evolve with time, but the Network has succeeded in continuously monitoring their needs. As a diverse, changing group that needs to be represented in different decision-making processes, I believe that the Network again this year has managed to be near women and girls and to transmit their needs best. With transparency, accountability, and constant debate, the Network remains a worthy voice of women and girls, as well as other vulnerable groups, including non-majority communities.

Many challenges remain. However, I would like to review some of the successes that mark 2015. This year the Network continued to support the Kosovo Women's Fund, a fund that has offered the opportunity

for women in villages and cities alike to make their voices heard in decision-making processes at local and central levels. Many women's organizations have not had the opportunity to organize activities, due to a lack of basic funds for their work. Today, such NGOs have carried out important initiatives thanks to KWN's

proper management of this Fund, as well as continued support from donors and their confidence in the work of the Network.

Also, for the first time in Kosovo, we have budget planning and analysis from a gender perspective at the local and central level, now obligatory for decision-makers in Kosovo [whom unfortunately are still mostly men who often do not understand the needs and interests of women and girls]. Thanks to the direct involvement of KWN staff and members, we now have the opportunity to see how our resources as taxpayers are distributed, and how the budget is allocated at local and central levels for men and women. If we have equitable distribution of these resources, we will have a more equal development.

These changes, however tiny they may appear, are actions that the Network has promoted and demanded for a long time. As the recently elected Canadian government has indicated, the equal division of governance by 50:50 men and women shows the degree of development of a society in the 21st century. We now have the Law on Gender Equality, which promotes the same equal participation in Kosovo as well. The Network will continue to support and promote the implementation and wider use of this Law.

I believe that the Network this year has shown that when there is a clear strategy, work, and vision, there is also a successful track-record. In the oversight role that we have for the realization of the rights of women and girls, as well as vulnerable groups such as young men and the elderly, the Network has continued to investigate and advocate with facts, including addressing the plight of persons who have suffered gender-based violence. In order to provide a realistic picture of the situation of violence, the Network published a comprehensive report on incidence and attitudes towards domestic violence. With advocacy based on facts, the Network continued to demand justice for victims who today are no longer with us because of delays in

justice. They have been denied justice, as in the case of Zejnepe Zejnullahu from Suva Reka, who was killed by her husband; her daughter was wounded while protecting her mother! We hope that justice will not be delayed further, that institutions will respond in time, and that appropriate penalties will be given in accordance with the law. There are no more excuses not to enforce the law, or not to provide equal opportunities for the growth and development of boys and girls!

With the motto to build a society where women and girls, including vulnerable groups, will have the opportunity to realize their full potential and have access to a more equitable distribution of resources, we will live in a more representative and democratic place. I wish you success in the coming year with the desire that such a motto becomes a reality.

INTRODUCTION

Our Vision

The Kosovo Women's Network (KWN) envisions a Kosovo where women and men are equal and have equal opportunities to education, employment, political participation, healthcare, and a life without violence.

Our Mission

Our mission is to support, protect, and promote the rights and interests of women and girls throughout Kosovo, regardless of their political beliefs, religion, age, level of education, sexual orientation, and ability. KWN fulfils its mission through the exchange of experience and information, partnership and networking, research, advocacy, and service.

Our Strategy

Towards achieving its vision and mission, KWN compiled a Strategy for 2015 through 2018 (available on our website). Its purpose is to guide KWN's work during this period. The Strategy was compiled in 2014 in consultation with KWN's members, Board of Directors, and other key partners and stakeholders. KWN's Strategy involves five programmatic areas: I) Building the Capacity of KWN; II) Women in Politics and Decision-making; III) Women's Right to Healthcare; IV) against Gender-based Violence; and V) Women's Economic Empowerment.

About Our Annual Report

Every year we report to our members, partners, and friends about the progress we have made towards achieving our strategic objectives. This report includes information related to KWN activities from 1 January to 31 December 2015. This report is divided in five sections, including one for each of our long-term objectives:

- Building the capacity of KWN
- Women in politics and decision-making
- Women's health
- Gender-based Violence
- Women's Economic Empowerment

In this report, we discuss progress made and results achieved in 2015 in relation to each of these programs. Each section includes information regarding progress made towards each expected outcome (bold, subheader text) and result (italic sub-header text). We also reflect on the overall achievement of our Strategic Plan for 2015-2018. The report also contains information about our budget, supporters, Board of Directors, Advisory Board, staff, interns, volunteers, members, and grant recipients.



BUILDING THE CAPACITY OF KWN

Our capacity-building program has the overall objective to ensure that a sustainable, women's movement exists in Kosovo. One indicator that KWN has progressed in achieving this objective is that implementation of the KWN Strategy for 2015-2018 has increased from 0% to 60%, based on the indicators for 2015. Further the number of individual KWN members has increased from 36 to 38; and young women and men have taken initiatives towards furthering the movement, demonstrating capacities of future generations to carry on the movement. KWN and Lobby members have remained active this year.

THE STATE OF SHIP STATE OF THE STATE OF THE

In 2015, KWN had the following outcomes and results, which contributed to the achievement of this overall objective, as foreseen by our Strategic Plan.

Solidarity among women-led organizations in Kosovo enhanced

KWN's experience suggests that furthering and maintaining solidarity among women-led organizations is crucial towards building a sustainable women's movement, lest gossip or competition undermine efforts towards joint goals. KWN made progress towards achieving this outcome through the following initial results.



KWN members informed of other members' initiatives, KWN activities, funding opportunities, and other useful information

KWN organized five bimonthly members' meetings through which 363 diverse members, partners, and supporters exchanged information; organized at least nine joint initiatives; and received information about KWN's and each other's ongoing activities. During meetings, KWN members played an important role in collaborating to implement KWN's strategy, as well as monitoring and evaluating KWN's work.

KWN regularly posted on the FemACT Facebook page and sought to involve young women and men activists in activities at municipal and national levels. KWN provided internships for ten young women. This provided opportunities for them to gain skills in organizing and advocacy as part of the Kosovo women's movement.

Strengthen inter-ethnic understanding and cooperation among individuals and civil society groups in Kosovo and Serbia

KWN continued efforts related to the Women's Court, including supporting the participation of five Kosovar women to testify at the Women's Court in Sarejevo. This was financed by the Heart and Hand Foundation through KWN; UN Women supported plane tickets for the participants directly. KWN also continued regional networking and cooperation supported by Kvinna till Kvinna, particularly related to Kosovo's European Union (EU) Accession process.

KWN also contributed to inter-ethnic understanding and cooperation through the Kosovo Oral History Initiative, an online archive of life stories of diverse Kosovars. The Oral History Initiative website (http://www.oralhistorykosovo.org/) contains filmed interviews; transcripts in English, Albanian, and Serbian; short stories; and photographs recording Kosovars' everyday lives. It aims to broaden the spectrum of Kosovo's history beyond the most recent war, by telling the stories and everyday life experiences of diverse women and men. This year the archive was further expanded with 27 new interviews of Kosovars, including women who were activists or teachers since the Second World War. Additional transcripts were published online in Albanian, English, and Serbian languages. Experiences were exchanged and collaboration enhanced with researchers, academics, and civil society representatives in Serbia who have contributed to expanding the archive, particularly in the Serbian language. This can contribute to inter-ethnic understanding of the diverse lived experiences of people in Kosovo.

In collaboration with the Gender Studies and Research Program of the University of Prishtina, the Initiative organized a two-day workshop on oral history methodology for students. Research this year focused on the Second World War, to which students could contribute. Then, in September, in collaboration with the Gender Studies and Research Program, Forum ZFD, and Alter Habitus the Initiative organized a two-day conference about memory in Prishtina, where research was presented. Internationally renowned oral historian Dr. Alessandro Portelli also provided lectures and a masterclass in Prishtina. Initially a primarily voluntary collaboration between KWN and The New School for Public Engagement in New York, the Initiative received support from individual supporters and then from the



National Endowment for Democracy and Forum ZFD starting in 2015. In July, the Kosovo Oral History Initiative registered as an independent association. From 2016 it will continue its work independently.

KWN has also provided opportunities for interethnic cooperation between organizations that received grants through the Kosovo Women's Fund: the Mitrovica Women's Association for Human Rights, with a staff with persons of different ethnicities (Albanian, Serbian, and Bosnian) collaborated to break stereotypes about women in politics and also to strengthen women's participation in decision-making processes in North Mitrovica, Zvecan, Leposavic and Zubin Potok. As a result they created together the Network of Assembly Women Groups. Another example is the successful cooperation between NGO Open Door and Ruka Ruci, which implemented their second joint project, empowering Albanian and Serbian women from Prishtina's villages, by bringing them together and teaching skills for advocating for their priority issues.

Improved the institutional capacity of KWN and its members towards greater advocacy capacity and the long-term sustainability of the network


A sustainable women's movement cannot exist without its members keeping the movement alive. Therefore KWN continuously supports its members in furthering their capacities. Workshops, mentoring, and the Kosovo Women's Fund have supported KWN members in strengthening their organizations.

KWN, its members, and their work more visible to potential partners, women activists internationally, and potential supporters

KWN regularly promoted the work of its members via the KWN website, Facebook page, and monthly e-newsletter *Kosovar Women's Voice*. KWN increased its diverse Facebook followers from 3,995 in 2014 to 5,595 in 2015. KWN's FemACT Facebook page and has 853 followers. KWN also manages the new *Lobi për Barazi Gjinore* [Lobby for Gender Equality] page, which now has 997 followers. KWN also started using other social media, such as Twitter this year (360 followers) and Instagram (500 followers).

In January 2015, KWN altered the way in which website usage is measured. This year KWN has had 6,517 page views, 2,256 sessions, and 1.605 users.

KWN regularly wrote articles about KWN members in our monthly newsletter *Kosovar Women's Voice*, which reaches hundreds of people around the world.

More members better able to fundraise, plan effectively, run organizations, and undertake effective advocacy initiatives

Building on achievements in prior years, KWN continued supporting its member organizations in developing their fundraising, planning, and advocacy capacities through the <u>Kosovo Women's Fund</u>. KWN member organizations have gained knowledge in drafting strategies for effective advocacy; partnering for

change; designing public relations materials: mainstreaming gender in public policies; and utilizing information and communication technology (ICT). Some organizations have challenged themselves by conducting research for the first time, analysing research data. and presenting their findings to



In 2015 KWN distributed 20 grants to its members through KWF, totalling €97,682.95.

different stakeholders. This has enabled them to advocate in a more professional and evidence-based manner.

This year, KWN provided 20 grants through the Kosovo Women's Fund. From these, nine Networking for Change grants (up to €8,000) were provided for 18 organizations working in partnership and 11 Individual Advocacy Grants (up to €3,000) were given to individual organizations. Networking for Change Grants have increased cooperation among member organizations, enabling organizations from different regions of Kosovo to join forces and strengthen their initiatives by advocating together. For example, Artpolis and Active Women of Gjakova developed a joint advocacy strategy in order to further the process of building mechanisms against sexual harassment at the University of Prishtina and Gjakova.

LIB ME SHEW AT

The main supporters of the Kosovo Women's Fund this year were the <u>Austrian Development</u> <u>Agency (ADA)</u> and <u>the European Union Office in Kosovo</u> who in total contributed together in the amount of € 97,683.

From autumn 2012 to 31 December 2015, 8,084 people have benefited from members' initiatives, including people with disabilities, people from rural areas, with different ethnicities (Turks, Gorani, Serbs, Roma, Ashkali, Egyptians, Bosnians, and Albanians), young people, and pensioners.

In 2015, KWN staff provided 226 mentoring sessions and had 410 contacts with Kosovo Women's Fund grant recipients. The Grant Review Committee, comprised of seven members, also contributed to furthering members' capacities by reviewing each application and providing practical suggestions. This has helped KWN members submit stronger applications to the Kosovo Women's Fund, as well as to other donors. At least six member organizations have applied to other donors and five have received financial support for their initiatives. Further, as of 31 December, KWN members achieved the following results are well as to other donors. The following results are well as to other donors. - Partners Center for Conflict Management, Partners Kosova, informed 60 women, men, girls, and boys from Rahovec and Malisheva how to advocate for women's right to property and inheritance. As a result, one woman from Malisheva took the courage to send this case to court and completed the legal procedures to obtain her right to inheritance.
- The Foundation for Education and Development (FED) brought together 13 Albanian and Serbian women, teaching them how to advocate together for priority issues. The training provided them with the skills they needed to advocate to the Mayor of Novobrdo Municipality for three issues: I) for the booth that was placed in the information centre in Novobrdo (a prior FED initiative funded by the Kosovo Women's Fund) to be relocated and re-opened near the Municipality building; 2) for the Red Cross to be more transparent in their activities; and 3) for at least two meetings on inheritance and property to be organized with the help of the municipality. They are waiting for these issues to be addressed.
- The organization Psychotherapists in Action offered 156 girls and 66 boys from Gjilan lessons on how to identify a potential situation of trafficking and how to avoid risky situations of being trafficked. The organization also advocated and raised awareness among local government bodies in Gjilan about the need for increased prevention efforts to protect citizens, especially young people, from trafficking.
- The Committee of Blind Women of Kosovo informed 56 people about the rights of blind people to free transport, guaranteed by the Law of Blind Persons, Article 13. As a result, the Committee and its members for the first time ever met with women members of parliament and women members.

of the assembly of Prishtina where they requested support in implementing this article. Women politicians committed to supporting blind women. The organization also successfully advocated to the Mayor of Pristina for urban traffic buses to be purchased in 2015 to meet the needs of persons with special needs. The Mayor promised that their demands would be taken into account. One step taken to date is establishing special trails on some sidewalks for blind persons, created for the first time in Prishtina.

- The Mitrovica Women's Association for Human Rights informed 35 women and nine men from North Mitrovica about the importance of women's participation in political processes. To strengthen cooperation between women politicians, they created Women's Assembly Groups in four municipalities in Northern Mitrovica and then created the Network of Women Assembly Members. This way women politicians there can join forces and work together in defending women's rights. This organization also advocated for the establishment of Gender Equality offices in these four municipalities.
- The Centre for Rural Development advocated to the Municipality of Novobrdo for women from this region to receive business grants.
- Ruka Ruci and Open Door established six community Albanian and Serbian women groups from three
 villages of Prishtina municipality and three villages of Gracanica municipality, These groups identified
 several issues that are of great importance for women living in this areas and they also met with
 representatives of departments of Prishtina and Gracanica municipality where they had the chance
 to learn about their role. These meetings also served to discuss existing mechanisms of participation
 and how to strengthen the two-way communication of women in developing and implementing

policies. In addition 450 women from these villages benefited through awareness raising sessions on women's rights.

 Ruka Ruci and Open Door created six groups of women from Albanian and Serbian community from three different villages of Municipality of Prishtina and three from three different villages of Municipality of Gracanica. These groups have identified several issues that are very important for women who live in these areas, they also met with representatives of the municipal departments of Pristina and Gracanica, where they had the opportunity to learn

about their role. These meetings also served to discuss existing participation mechanisms and how to strengthen mutual cooperation on the development and implementation of policies. More than 450 women benefited from these women's rights awareness raising session.

 The Association Women's Initiative conducted a research on women's health issues for the first time in Dragash with 170 respondents. The research showed that only 15,29% of the respondents had knowledge about the Law No. 04/L-125 on Health. When asked what they would change in the health

system, the respondents gave priority for health institutions to have regular supply of medications, higher standards of hygiene, employ women doctors, having healthcare etc. Women's initiative presented these findings to local institutions in Dragash municipality and they achieved to arrange a presentation of these findings and recommendations in the next session of the Municipal Assembly in Dragash.

KWN staff capacities increased

KWN continued offering opportunities for its staff members to further their capacities in 2015:

- 1. On 4-5 June, Nicole Farnsworth and Donjeta Morina participated in a two-day workshop on the EU Gender Equality Index together with Kosovo institutions. Following a detailed presentation of the Index and the methodology behind it by the European Institute for Gender Equality, participants discussed next steps for developing the Index in Kosovo.
- 2. On October 5-9, the Promoting Private Sector Employment (PPSE) project in Kosovo held a Gender in Value Chain Development Course, attended by Nertila Qarri Gërguri, Project Coordinator. The training provided tools for including gender in the analysis of value chains and devising gender strategies that enhance empowerment and income for all stakeholders. This will strengthen KWN's ability to support its members focusing on women's economic empowerment in the future.

- 3. On October 21-22, Donjeta Berisha, Public Relations Coordinator, participated in the Stockholm Internet Forum (SIF), an international forum that promotes in-depth dialogue and discussions on how free, open, and secure internet access promotes and strengthens human rights worldwide. Discussions related to economy, technology, policy, and human rights with a special emphasis on gender equality.
- 4. In November 2015, Donjeta Morina, Capacity Development Coordinator, attended a one-week workshop organized by Kvinna till Kvinna in Brussels. It enhanced advocacy skills at the EU level. She also met with various officials in Brussels to advocate for issues in Kosovo from a gender perspective, including representatives from the Directorate General for Neighbourhood and Enlargement Negotiations (DG NEAR), the European External Action Service (EEAS), and the Committee for Foreign Affairs at the European Parliament.
- 5. Adelina Berisha attended a workshop on Rehabilitation and Reintegration for Domestic Violence survivors provided by <u>OSCE</u>.
- 6. Most staff members attended the KWN workshop on gender mainstreaming in policy documents, as well as received mentoring in providing comments on policy documents before and after.
- 7. The respective KWN research teams received training on the legal framework related to domestic violence, sexual harassment, and the labour law, as well as ethics in research with human beings.
- 8. Based on their responsibilities, KWN staff members received on-the-job coaching on: gender responsive budgeting, budget analysis, interviewing skills, writing concept notes, report-writing, monitoring and evaluation, research methods, sample selection, public speaking skills, and online document sharing.

The funding climate for women's rights organizations improved

Although several advocacy initiatives can be taken on a voluntary basis, women-led CSOs still require resources for many aspects of their important work. Sustainable activism towards women's rights requires resources, and KWN continues its efforts towards mobilizing sufficient resources from local and international actors towards sustaining the women's movement in Kosovo and beyond.

KWN Fundraising Plan implemented

KWN continued fundraising in 2015 and was able to secure most resources needed for making progress on implementing its strategy this year.



INCREASING WOMEN'S PARTICIPATION IN POLITICS AND DECISION-MAKING

The long-term objective of this program is that women participate actively in politics and decision-making at municipal and national levels. KWN has made progress towards achieving this objective as the following outcomes and results illustrate.

Women's participation in politics and decision-making at municipal and national levels increased and improved as per the Law on Gender Equality

If women are to participate actively in politics and decision-making at municipal and national levels, the number of women participating and the quality of their participation must be improved. Towards achieving this objective, 358 diverse women citizens participated in politics and decision-making processes via members' KWF initiatives. And 815 women participated through Lobby for Gender Equality in Kosovo. In 2015, Lobby had 949 members from 25 different municipalities, and during 2015 Lobby members, undertook 184 advocacy initiatives, where were involved 1345 women resulting 13 policy changes.

At the same time, the quality of participation has improved, demonstrated by the issues discussed between women and officials through this action. KWN contributed to this through the following results in 2015.

Gender Equality Advocacy Groups (GEAGs) established and functioning in 25 municipalities and at the national level

On 21 November 2014, 64 GEAG members held their third meeting in Struga, Macedonia. During this meeting, women from politics and civil society from 17 municipalities established the Kosovo Lobby for Gender Equality. Members decided that men and boys who support equal rights for women and men also can join this group. Members of the Lobby "commit to working together towards achieving gender equality in Kosovo, regardless of our political party affiliation, gender, age, ethnicity, ability, religion,

geographic location, level of education, or socioeconomic status," according to their declaration. At present, Lobby groups exist in 25 municipalities.

On 25 February, 52 municipal assembly members, gender equality officers, and civil society representatives gathered in Prishtina to discuss joint advocacy initiatives regarding war rape survivors; the Law on Inheritance; and advocacy activities planned for 8 March, International Women's Day. They exchanged information and best practices, which helped them finalize existing ideas and arrive at new ones.

Then, on 8 March, Lobby members set aside flowers and focused on advocating for and raising awareness about women's rights within their municipalities. They emphasized that International Women's Day is about the historical and ongoing struggle for women's rights in Kosovo and beyond. They hosted several events in different municipalities, including: screening the film "Iron Jawed Angels" about U.S. suffragists' struggle to vote; visiting women in the Lipjan women's prison; marching and hosting demonstrations at the municipal level on various issues related to women's rights; and meeting institutions towards improving services for women.

On 17-19 April, approximately 94 women representatives from politics and civil society from 23 municipalities gathered for a three-day Lobby meeting in Durres, Albania. Members divided into groups by municipality to identify three issues in their municipality and one issue at the national level on which they would advocate together in 2015. They also received information about the National Council on Survivors of Sexual Violence during the War from Jeta Krasniqi, Political Advisor of the President of the Republic of Kosovo; and watched movies "Three windows and a hanging" and the documentary "Levizja e Gruas" (Women's Movement) for the 20th anniversary of the women's movement in Albania. Albania's Minister of Urban Development Eglantina Gjermeni talked about her career from her experience in civil society to her current life in politics.

To make this meeting happen Lobby's member contributed 920 euro.

On May 28, 250 participants from the Lobby for Gender Equality, KWN, members of families of war martyrs from the Municipality of Dragash, donors, friends and supporters of KWN gathered in a joint meeting. Participants gave President Jahjaga dresses and skirts that they had collected to contribute to the source.

artistic installation "Thinking of you" by artist Alketa Xhafa-Mripa. The installation was dedicated to women survivors of sexual violence perpetrated during the war in Kosovo and was organized by the National Council of Survivors of Sexual Violence during the War, established and led by the President of the Republic of Kosovo, Mrs. Atifete Jahjaga. During the second part of the meeting Lobby and KWN members discussed advocacy initiatives.

Capacities of women in politics to advocate for women's priorities furthered

The aforementioned Lobby meetings also furthered the capacities of women in politics to advocate for women's priorities by providing examples of best practices and enhancing their existing advocacy skills. They attained knowledge on what GRB is; how to include it in budget documents (local and central level); and knowledge on the new legal framework surrounding GRB. KWN provided ongoing mentoring to women in politics, supporting them in their advocacy efforts.

Additionally, KWN met with women and men gender equality officers at municipal and ministerial levels and representatives of line ministries, supporting them in mainstreaming gender in Sectoral Planning Documents and Action Documents that they were drafting for the EU Instrument for Pre-Accession Assistance (IPA). KWN supported mainstreaming gender in five Sector Planning Documents and 15 Action Documents. This involved on-the-job coaching for 24 women and 12 men in politics on how to mainstream gender in these documents, thereby ensuring women's priorities and needs are sufficiently considered. KWN also provided training and mentoring for three gender equality officers in ministries on how to mainstream gender in IPA documents, specifically Logical Frameworks, as well as supported them

in advocating for women's needs to be considered in these documents. This was financed by the EU Office in Kosovo.

KWN also provided training to gender equality officers from ministries and municipalities on gender responsive budgeting and how to implement it in their work. This included practical exercises on reviewing draft budgets from their respective institutions and preparing comments on these documents from a gender perspective.

On 21 September, KWN organized a training on gender mainstreaming in public policies attended by KWN members, as well as eights municipal assembly members and gender equality officers from the Lobby for Gender Equality. Following a brief introduction on strategies for mainstreaming gender in public policies, KWN distributed several policies of importance to women and working groups collaborated to comment on these policies from a gender perspective.

KWN collaborated with the Kosovo Institute for Public Administration (KIPA), Agency for Gender Equality, and GIZ Legal Reform Program to organize meetings with women and men in politics in seven municipalities (Gjakova, Skenderaj, Drenas, Decan, Peja, Rahovec, and Mamusha). KWN presented briefly the new legal framework on gender equality and discussed challenges that officials have faced in implementing the legal framework to date, towards problem-solving and addressing these. Examples from these experiences (as well as from other municipalities and ministries) will be used to inform case studies and the design of KIPA's new curricula on gender equality in 2016. KIPA's new curricula for civil servants and gender equality officers, respectively, will further the capacities of both women and men to consider women's priorities in the future.

Initiatives taken by six KWN member organizations supported by the Kosovo Women's Fund this year, have involved 317 women in decision-making processes (meetings with local authorities, doing advocacy). For some of these women, this was the first time that they ever were involved in a decision-making process.

Awareness of the importance of aligning the Law on Gender Equality and electoral laws enhanced

As a member of the official governmental working group drafting the new Law on Gender Equality, the Kosovo Women's Network (KWN) had the opportunity to review and provide detailed comments on several versions of the draft law. The process, which began in late 2015, has since concluded. From the more than 20 comments that KWN made on the most recent draft of the Law, seven were reflected in the new Law on Gender Equality (No. 05/L -020), adopted on 28 May 2015. Some of the comments provided by KWN that have been reflected successfully in the new Law include:

- Article 5.1.8: All institutions should collect gender-disaggregated data and submit it to the Agency of Statistics of Kosovo (ASK)
- Article 8.1.9 and 8.12: Analyses of the status of gender equality in Kosovo together with a report on the implementation of the law should be published and made publicly available
- KWN, among other key stakeholders such as the Agency for Gender Equality and GIZ advocated successfully for the Law to require all institutions in Kosovo to carry out gender budgeting.

During working group meetings and in follow-up advocacy, KWN has emphasized the importance of aligning this new Law with the electoral laws, which would mean requiring women's and men's 50% participation at all decision-making levels.

Women in politics, women-led NGOs, and women voters communicate and cooperate more around issues women consider priorities

Through Lobby and KWN members, women in politics, civil society, and women voters have all collaborated around issues of importance to them in 2015. This has included related to public support and reparations for women who suffered sexual violence during the war; on increasing women's awareness regarding their rights to inheritance and property rights; and on several other issues at the municipal level.

Advocacy initiated on issues women consider priorities

In 2015, KWN set a record regarding the number of political processes and policies in which KWN advocated women's priorities. KWN participated in several governmental working groups and/or provided comments on laws and policies that will impact women's and girls' lives. KWN supported gender mainstreaming by analysing draft public policies (laws, administrative instructions, strategies, action plans) from a gender perspective and assessing the potential impact that they can have on men, women, girls,



and boys. In 2015, the policies that KWN reviewed from a gender perspective and/or provided input on included:

KWN then advocated for officials to accept KWN's additions, towards better reflecting women's priorities and needs in public policies.

In addition to participating in these policy processes, KWN advocated for several other issues of importance to women. These included:

- 26. Institutionalizing gender responsive budgeting in the Ministry of Labour and Social Welfare (MLSW)

- 31. For the Ministry or European Integration to ensure that all policies and laws passed in accordance with Kosovo's EU Accession include a gender perspective
- 32. Against domestic violence and for the implementation of the legal framework pertaining to domestic violence by all relevant institutions

KWN in cooperation with the Lobby for Gender Equality started the campaign "I DARE" to raise awareness about the legal framework protecting women and girls. "I DARE" is a play that consists of five monologues dealing with issues of war rape, domestic violence, sexual harassment at work, and women's right to inherit property. The plays end with a positive message, empowering girls and women to realize their rights and use the applicable legal framework. "I DARE" was performed in Dragash, Rogove, Lipjan, Drenas, Viti, Prizren, Kaçanik, Hani i Elezit, Deçan, and Gjilan, attended by more than I 200 persons. The

actors are Kumrie Hoxha, Makfire Miftari, Florentina Ademi, Safete Rogova, and Molika Maxhuni. This campaign is supported by the Dutch Embassy.

Through the Kosovo Women's Fund, KWN also supported six advocacy efforts by KWN members, detailed in the prior section of this report.

Towards this result, KWN also sent three advocacy letters to officials this year:

Institutionalization of Gender Responsive Budgeting in Kosovo improved

Gender responsive budgeting is important not only for women's increased and improved participation in decision-making but also for the efficient and equitable distribution of public funds. Therefore, KWN is building on prior best practices, using a method developed with GIZ and international expertise to work towards institutionalizing gender responsive budgeting (GRB) in Kosovo.



Capacities of targeted officials for carrying out GRB enhanced

In total 134 officials, civil servants, and students were trained in 2015, bringing the total number of people trained by KWN on GRB to 153 persons. People trained included finance officers, heads of finance in municipal directorates, representatives of ministerial departments and divisions, as well as Gender Equality Officers (GEOs). Additionally, 33 people were mentored in GRB, bringing the total number of persons mentored by KWN to 60. Several officials' capacities were clearly enhanced, as demonstrated by the extent to which Gjakova; Kamenica; and the Ministry of Education, Science, and Technology included gender analysis in their 2016 budget documents.

Concrete recommendations for improved gender responsive budgeting presented to relevant officials towards institutionalizing GRB

In 2015 KWN witnessed several milestones and successes related to GRB. Due to KWN's advocacy and mentoring, the following changes in policies and documents occurred this year:

- The Ministry of Finance included specific references, paragraphs, and table templates in its Budget Circular 2016/02 for Central budget organizations. Central Budget Organizations were encouraged to integrate GRB in their budget documents.
- The Ministry of Finance similarly included specific references, paragraphs, and table templates in its Budget Circular 2016/02 for Local budget organizations.
- The Municipality of Kamenica integrated GRB in its Mid-term Budget Framework, and has the most gender responsive document of all municipalities in the Republic of Kosovo.



- As of July 2015, GRB is a legal obligation as KWN advocacy contributed to it becoming part of the new Law on Gender Equality 05/L-020.
- The Municipality of Kamenica integrated GRB in its annual Budget document for 2016, becoming one of the first municipalities in Kosovo to add gender disaggregated data as an annex to its annual budget.

- The Municipality of Gjakova integrated GRB in its annual Budget document for 2016, becoming one of the first municipalities in Kosovo to add gender disaggregated data as an annex to its annual budget.
- Ministry of Education, Science, and Technology added gender disaggregated data in its annual budget sent to the Ministry of Finance.



KWN published the research report Budgeting for Social Welfare on the gender responsiveness of MLSW services.

KWN also published the research report *Budgeting for Social Welfare* on the gender responsiveness of MLSW services and MLSW expenditures in two economic categories: wages and salaries, and subsidies and transfers. The report includes several recommendations aimed at supporting MLSW in planning its mid-term expenditures in a more gender sensitive manner. To read the full report, click here.

IMPROVING WOMEN'S ACCESS TO QUALITY HEALTHCARE

The long-term objective of this program is that "women have access to and are accessing affordable, quality healthcare." KWN has not yet been able to secure funding for this program. Even so, thanks to KWN members, including those supported by the Kosovo Women's Fund, some progress has been made.

Public officials and health institutions held more accountable for addressing violations of women's right to healthcare

KWN sent an official letter to the Gynaecology Institute requesting better quality care for mothers giving birth there. KWN advocated not to build a jail in the hospital, but to have a separate hospital for imprisoned persons in Kosovo with a professional staff that would meet international standards, both in terms of professional and health services delivery. The letter also requested that gender budgeting be implemented in 2016.

KWN also attended to women's health needs during pregnancy and after birth as part of its working paper on the Labour Law (see below), including recommending sufficient paid leave from work for medical exams. KWN plans to work more towards achieving this objective in future years.



More women and girls aware of their rights and the importance of accessing healthcare; more women aware of how to detect signs of cancer

The Women's Initiative, supported by the Kosovo Women's Fund worked to improve women's health in Dragash Municipality by conducting a research and presenting its findings to public officials and other health care providers in Dragash Municipality. The research showed that only 15.29% of the respondents had knowledge about the Law No. 04/L-125 on Health. When asked what they would change in the health system, the respondents gave priority for health institutions to have regular supply of medications, higher standards of hygiene, employ women doctors, having healthcare etc. Also supported by the Fund, the Centre for Promotion of Women's Rights just began an initiative to raise awareness about women's right to healthcare. They are advocating for at least 80 women from four villages near Drenas to receive free gynaecological exams.

Research exists documenting violations of women's right to healthcare

KWN has drafted the research methodology and survey instrument that will be used to carry out this research in 2016. The survey was piloted in Dragash Municipality by Women's Initiative this year. They surveyed 170 randomly selected respondents in Dragash, mainly women. The research showed that only 15.29% of the respondents had knowledge about the Law No. 04/L-125 on Health. When asked what they would change in the health system, the respondents gave priority for health institutions to have regular supply of medications, higher standards of hygiene, employ women doctors, having healthcare etc.

KWN now is working to raise funds to carry out Kosovo-wide research and to train and involve its members in documenting rights violations in 2016, an initiative that will be carried out in partnership with Dartmouth College Colleg

More public officials, women, girls, and men are aware of women's right to healthcare and violations of women's right to healthcare

The Women's Initiative plans to gather officials from public health institutions and Dragash Municipality to discuss their aforementioned research findings.

More women access quality healthcare

KWN will work on this in future years, though KWN members have undertaken some initiatives.

Women and girls more aware of their right to healthcare and the importance of accessing healthcare

On 17 October, Jeta-Vita Centre for Fighting Breast Cancer, hosted their annual information and cultural program against breast cancer. Participants marched, chanting "Early Detection Equals Survival," boosting morale and raising awareness about breast cancer in Kosovo. The program was organized under the patronage of the President of Republic of Kosovo, Atifete Jahjaga. The program gathered hundreds of citizens, including KWN staff and other organizations, as well as high level state representatives. Jeta-Vita organized additional activities during breast cancer awareness month.

More women advocate for their right to quality healthcare

KWN will work on this in future years.



A LIFE FREE FROM GENDER-BASED VIOLENCE

The long-term objective of this program is that women and girls live a life free from gender-based violence. KWN has made progress towards achieving this objective as the following outcomes and results illustrate. This year KWN focused on setting a clear baseline by realizing very important research on domestic violence and sexual harassment, respectively. In the end of the year, KWN also began advocacy efforts for the implementation of the recommendations resulting from this research. KWN will continue this advocacy in 2016, measuring changes that occur in 2017.

Implementation of the domestic violence legal framework, including institutional response in assisting persons who suffered violence, improved

KWN will work towards this objective in future years, based on its research findings in 2015.

Follow-up monitoring reports exist on the implementation of the domestic violence legal framework, as well as awareness about and extent of domestic violence KWN surveyed 1,315 Kosovars (51.6% women and 48.4% men) to measure awareness, attitudes, and incidence of domestic violence; and conducted interviews with 200 representatives of public institutions and civil society organizations responsible for implementing the legal framework pertaining to domestic violence. In November, KWN published a comprehensive report on domestic violence in Kosovo

entitled <u>No More Excuses: An Analysis of Attitudes, Incidence, and Institutional Responses to Domestic Violence in Kosovo</u>. It includes a review of the implementation of the legal framework to date. This is a follow-up study to the 2008 research entitled <u>Security Begins at Home</u>, and it assesses changes that have occurred since then. The research found that 62% of respondents (68% women and 56% man) had experience violence at some point in their life. In 2014 alone, 31% of respondents had suffered domestic violence.

Institutions and other actors aware of the extent to which the domestic violence legal framework has been implemented

No More Excuses was published on 23 November during the official governmental Working Group currently drafting the new National Strategy against Domestic Violence and the Action Plan for the period of 2016-2020. Several representatives of key institutions and other actors participated in the launching event. KWN also produced four fact sheets with specific recommendations for the Working Group to consider related to each of the three objectives of the new strategy, as well as overall recommendations for the Strategy. In 2016, KWN will c ontinue raising awareness among institutions regarding the extent to which the legal framework has been implemented.



KWN was invited by the EU Twinning Project "Re-Offending Prevention Program (RPP)" to train officials from Correctional and Probations Services in Kosovo. KWN provided five training sessions to 88

social workers, probation officers, and other representatives from these institutions on basic concepts of gender equality; legal obligations that they have related to domestic violence; on the main findings from *No More Excuses;* treating perpetrators of violence; and the importance of cooperating with civil society, particularly shelters. Training focused on the responsibilities that each institution has in providing such treatment and strategies for offering these services. Participants were satisfied with the training, noting that this was their first time to discuss domestic violence and sexual violence specifically.

KWN staff member Nicole Farnsworth and Board Chair Ariana Qosaj-Mustafa also provided training to representatives of regional employment centres and vocational training centres on their role in assisting the rehabilitation of persons who have suffered domestic violence. This included their legal responsibilities and the appropriate approach in assisting persons who have suffered gender-based violence who likely suffer from trauma. This was funded by the United Nations Development Programme, outside KWN's official activities.

Based on the findings from the research, KWN organized initial discussions with two KWN member organizations to begin drafting the advocacy and awareness-raising strategy for 2016. KWN will seek to involve more members in this advocacy from next year. Additionally, several KWN members were involved in advocating for the implementation of the legal framework within their municipalities, particularly during the 16 Days against Violence against Women. Several KWN members also were involved in the municipal coordination mechanisms for addressing domestic violence in accordance with the legal framework.

Performance and quality of services of shelters enhanced, particularly towards rehabilitation and reintegration

KWN continued to advocate for sustainable funding for shelters at both central and municipal levels, as well as improved monitoring of the quality of services. This included through specific recommendations made to MLSW in KWN's new report, (*Budgeting for Social Welfare* (2015). KWN had recommended in 2014, including based on its prior research, that shelters should be compensated per person sheltered, which has been implemented by the Ministry starting in 2015. The process of licensing social workers and shelters has been almost entirely completed by the Ministry this year. Now KWN is advocating for continued monitoring in future years.



Awareness of and attention to addressing gender-based violence improved among officials and citizens, including domestic violence, rape, and sexual harassment

Based on the research findings, KWN will work more on awareness-raising in 2016.

More citizens informed about the legal framework and their rights, including men

For women and girls in Kosovo, sexual harassment remains a key concern related to their safety and security. In late 2014, KWN organized a campaign aimed at raising awareness about sexual harassment. "Take Back the Night" involved citizens in expressing their concerns regarding sexual harassment, using social media and a public demonstration. In 2015, KWN conducted the first Kosovo-wide research on various forms of sexual harassment in different locations to identify the incidence, as well as citizens' awareness and attitudes towards sexual harassment. This involved a survey of 1,315 women and men, as well as interviews with representatives of approximately 200 institutions. KWN is finalizing the report, which will be published in early 2016. It will serve as the basis for an awareness-raising campaign on this issue.

KWN members also have been active. For example, Artpolis and Active Women of Gjakova with a Networking for Change Grant, supported by the Kosovo Women's Fund, began an initiative to address sexual harassment in the public universities of Prishtina and Gjakova by advocating for the establishment of mechanisms within these institutions. This has included raising awareness among students about their legal rights. Their work continues.

Improved policies and procedures for addressing sexual harassment exist

KWN is continuing to collaborate with its members in advocating for these starting in 2016, based on the recommendations resulting from the research to be published in early 2016.

Coordination established among women-led CSOs, public institutions, and other workplaces towards installing improved mechanisms for reporting and investigating cases of sexual harassment

As mentioned, Artpolis and Active Woman Gjakova to collaborate with the University of Prishtina and the University of Gjakova to establish policies against sexual harassment, including improved reporting mechanisms. KWN plans to take further steps towards this result in 2016, based on the research.

Institutional and public support for persons who suffered sexual violence during the war improved

In a crucial development, Kosovo President Atifete Jahjaga established the National Council for Survivors of Sexual Violence during the War on March 7, in which KWN is a member. The Council brings together representatives of key ministries that can support violence survivors, civil society, and international stakeholders towards an improved, better coordinated response. The Council was established in response to concerns and issues raised by women who had suffered sexual violence, following discussions between

President Jahjaga and women, facilitated by KWN in prior years. KWN has supported women survivors in advocating for institutions to better address their needs. Now KWN is advocating for the Council to have a permanent budget and mandate, as well as for permanent funding for survivors.

KWN and its members involved in processes towards ensuring institutional and public support for persons who suffered sexual violence during the war improved

With support from the Legal Office at the Prime Minister's office and UN Women, the National Council on Survivors of Sexual Violence during the War, under the leadership of President Atifete Jahjaga organized a workshop in Tirana on 15-18 January 2015. The workshop gathered a delegation from Bosnia and Hercegovina, members of the National Council on Survivors of Sexual Violence during the War in Kosovo, and other participants to exchange experiences on rehabilitation, reintegration, and empowerment of survivors.

With support from UN Women, OHCHR, and the Legal Office in the Prime Minister's Office, the Council has begun drafting instructions for the implementation of the new Law on Recognizing the Status of Martyrs, Invalids, Veterans, KLA Members, Persons Raped during the War, Civil Victims of the War and Their Family (2014). The law provides them with personal pensions, among other benefits. In March 2015, the Council drafted and finalized the necessary bylaws for recognition and verification of the status of victims of sexual violence during the war. These documents will enable persons who suffered sexual violence during the war to apply for assistance as foreseen by the aforementioned Law and based on the International Protocol for Documentation and Investigation, as well as best practices in the region.

Then, from 9 May to 6 July, the National Council for the Survivors of Sexual Violence during the War organized several activities to improve public support for persons who suffered sexual violence during the war. Under the auspices of the Council, KWN, its members, and Lobby supported artistic installation "Thinking of you" by artist Alketa Xhafa-Mripa, which is dedicated to women survivors of sexual violence perpetrated during the war. KWN organized several activities throughout Kosovo to collect skirts for this exhibition, and more than five thousand dresses and skirts were collected. These were subsequently displayed at the Prishtina Stadium on 12 July.

KWN also participated in a panel discussion on the topic: "Support for survivors of sexual violence during the war" organized in Prizren during the popular documentary film festival "Dokufest". The discussion sought to raise public awareness

about the consequences that sexual violence has on survivors and society, as well as the importance of justice and reparations.



FURTHERING WOMEN'S ECONOMIC EMPOWERMENT

The long-term goal of this program is: women and men have equal economic opportunities at home and in the public sphere.

More women secure employment

KWN made some progress towards this long-term objective that women have equal access to employment opportunities in Kosovo. One indicator is the number of women who secure employment following KWN and its members' advocacy and/or support, which increased from 24 to 241 in 2015.

Institutions and key actors more aware of the extent of gender discrimination in the workplace in Kosovo and ways to address it

Driven by an official request from the Minister of Labour and Social Welfare, Mr. Arban Abrashi, for recommendations for the new Labour Law and our belief that an important law like this should be based on evidence, KWN conducted research to inform the new Labour Law with evidence-based findings on topics including gender discrimination at work, particularly related to maternity and paternity leave. KWN conducted 400 interviews with a random sample of employers. KWN also surveyed 1,301 women and 374 men. KWN received no funding for this initiative and depended on citizens' contributions and voluntarism to realize this important research. Most work has been done thanks to KWN team members working overtime and our dedicated volunteers and interns.

KWN presented the initial findings from this research together with key recommendations to the Kosovo Economic Social Council (KES) and will soon send the policy recommendations in writing to the Ministry. KWN plans to publish and make publicly available the final recommendations in early 2016.

CORNER VINCENT

More, affordable child care opportunities available

KWN has drafted a working paper on the importance of child care in Kosovo, which was presented to diverse representatives of institutions, academia, students, civil society, and donors in Kosovo during the UBT conference on Gender and Economy held on 10 November. KWN also has included the importance of childcare among its key recommendations in the policy paper to be presented to the MLSW and KES, which are currently drafting the new Labour Law. KWN has advocated for the importance of opening more, affordable childcare care facilities during meetings with several officials, including from the Ministry, and donors in Kosovo. Advocacy will continue in future years.

Further institutional and private sector capacities for placing women in jobs

KWN has liaised with several donors that have programs related to the private sector and women's employment, as well as supported the establishment of and participated actively in the Women's Economic Empowerment Coordination Group, now chaired by USAID EMPOWER. KWN has made recommendations to several donors regarding strategies for reaching women and identifying potential jobs for them.

KWN collaborated with Open Data Kosovo and Girls Coding Kosovo to raise funds for a joint initiative to provide hands-on workshops and internships to young women in application development for smart phones. They are working on developing a specific phone application for the social good, funded by USAID EMPOWER, the Canada Fund for Local Initiatives, and MLSW. Such internships are crucial for young women to gain experience that they can use in identifying and applying for future jobs.

As mentioned, KWN staff also have provided trainings to regional employment centres and vocational training centres in order to further their capacities and skills for placing women in jobs.

More women access their right to inheritance and property

KWN has continued collaboration with other actors working in this regard, including through the Gender Coordination Group on Property Rights Program (PRP), which KWN supported to be established in 2015. KWN has sought funding to carry out initiatives that will support women in accessing their right to inheritance and property. However, as most efforts have been on a voluntary basis to date, KWN has not yet achieved this result.

More citizens aware of women's right to inheritance and property

In 2015, Partners Kosova started the "Women's advocacy for gender equality, their right to inheritance and property", with €2,390 from the KWN Kosovo Women's Fund. The initiative informed 34 women and 26 men from Malisheva and Rahovec about this. Following on the success of this initiative, Partners Kosova in partnership with NGO Aureola (€7,604) received a Networking for Change Grant. They will work together to inform women and girls of Vushtrri, Podujevo, and Kastriot so that they can realize their legal rights in property and inheritance. They also will offer continued assistance to women who want to register their property or heritage. Results of this ongoing initiative will be published in 2016.

More women take steps to secure their right to inheritance and property

During 2015, 294 women took part in meetings on awareness raising for their rights on property and inheritance. From them 47 women have requested their right on inheritance and property supported by KWN members.

Relevant officials held more accountable to respecting women's right to inheritance and property

Partners Kosova organized a roundtable in Rahovec about women's right to property and inheritance. Women discussed this issue with representatives from courts (civil court judges), Legal Aid Offices, the Office for Gender Equality, women's organizations, mediators, the Director of the Cadastre and Geodesy

Office, Office for Integration, teachers, and students. KWN plans to undertake additional actions together with its members in coming years.

Women's access to resources within the family improved

KWN worked on fundraising for this aspect of its strategy this year, which has not yet been successful despite multiple proposals submitted in 2015.

However, the Lawyers Association NORMA and the Centre for Women's Empowerment (CWE) are contributing to this outcome by advocating for better implementation of the right to alimony support. They are advocating for an Administrative Instruction based on the Family Law that will establish a special mechanism for monitoring the implementation of the right to alimony. For this initiative, they received a

Networking for Change grant from the Kosovo Women's Fund and will continue these efforts into 2016. Importantly, alimony support would improve women's access to resources, particularly in situations of divorce and/or domestic violence.

Research completed on equal access to resources within the family

KWN has discussed with the MLSW, GIZ, and UNDP the importance of conducting this research. It was again among the recommendations in KWN's publication *Budgeting for Social Welfare* in 2015. KWN continues to seek funding for this to be implemented.



Institutional awareness of alternative models of distributing social assistance enhanced

KWN planned to support a study visit with the MLSW to Albania to learn from their experience in distributing social assistance to women. However, due to the slow formation of the government and political changes in the Ministry, this had to be postponed. KWN is in discussions with MLSW and GIZ as to whether it would still be useful in the future.

The extent to which EU policies and programs involve a gender perspective improved

Oversight from a gender perspective related to EU policies and programs in Kosovo improved

The European Union (EU) offers financial assistance to candidate countries as well as potential candidate countries. As the Republic of Kosovo is a potential candidate country, it receives IPA funding as well. In 2015, KWN assisted line ministries and the EU Delegation in Kosovo in mainstreaming a gender perspective in IPA Action Documents, and Sectoral Planning Documents (SPD). In total, KWN delivered 18 mentoring sessions and one workshop to a total of 36 participants (24 women and 12 men). These have contributed to increased understanding of how gender can be mainstreamed in IPA documents. For Gender Equality Officers, the workshop and mentoring contributed to increased knowledge of the IPA process, logical frameworks, and how they can contribute to these processes from a gender perspective.

As for documents, KWN reviewed a total of five draft Sector Planning Documents and 15 draft action documents, providing input from a gender perspective.

KWN also provided comments to inform the 2015 Progress Report for Kosovo from a gender perspective, as well as reviewed the Draft National Program for Implementing the Stabilisation and Association Agreement from a gender perspective.

EVALUATING KWN'S WORK

In every meeting and training that was organized this year, KWN members evaluated the work of KWN through questionnaires completed at the end of each event. In general, members evaluated KWN's work in 2014 very positively. Members evaluated KWN meetings as "very important" and "very useful" and the work of staff "excellent".


