LETTER FROM THE CHAIR OF THE KWN BOARD

We are ending a year which, more than ever, confirms the relevance and necessity of the work of KWN.

We, as activists, need KWN to constructively unveil our will, be together, and have a stronger voice that unstoppably requests equality. Above all, the region needs KWN as an example of dedicated work and commitment to equality and justice. Our Vision

The Kosovo Women's Network (KWN) envisions that in the state of Kosovo women and men are equal and have equal opportunities to education, employment, political participation, healthcare and a life without violence

Our Mission

Our mission is to support, protect and promote the rights and interests of women and girls throughout Kosovo, regardless of their political beliefs, religion, age, level of education, sexual orientation and ability. KWN fulfils its mission through the exchange of experience and information, partnership and networking, research, advocacy and service.

Our Strategy

Towards achieving its vision and mission, KWN compiled a Strategy for the period 2015-2018 (available on our website). Its purpose is to guide KWN's work during this period. The Strategy was compiled in 2014 with the data from KWN's members, Board of Directors, partners and other key stakeholders. KWN's Strategy involves five programmatic areas: I) Building the Capacity of KWN; II) Women in Politics and Decision- making; III) Women's Right to Healthcare; IV) Domestic Violence and Trafficking; and V) Women's Economic Empowerment.

About the KWN Annual Report

Every year, the Network reports to its members, partners and friends about the progress that was made towards achieving the strategic objectives. This report includes information related to KWN activities from 1 January 2017 to 31 December 2017. This year, KWN has decided that this report will not be printed contributing to environmental protection, respectively woods. This report is divided into five sections that include the long-term objectives of the network:

- Building the capacity of KWN program;
- Supporting women's participation in politics and decision-making;
- Improving women's access to quality healthcare;
- Decreasing gender-based violence;
- Furthering women's economic empowerment.

In this report are presented the achievements and results for 2017 related to each of these programs. The sections that follow include information regarding progress made towards each expected outcome (bold text) and result (italic text). It also reflects on the achievement of the Strategy 2015-2018. This report also contains information about budget, supporters, Board of Directors, Advisory Board, staff, interns, volunteers, members and grant recipients.



BUILDING THE CAPACITY OF KWN

The main objective of the KWN's capacity building program is to have a sustainable movement of women in Kosovo. An indicator that KWN has progressed in achieving this objective is that KWN, until the end of 2017, implemented 79% of its Strategy for 2015-2018.

Moreover, the number of individual KWN members has increased from 53 to 59; and young women and men have taken initiatives towards furthering the movement, demonstrating capacities of future generations to carry on the movement. KWN and the Lobby members for Gender Equality in Kosovo have continued to be very active and loud during this year.

In 2017, KWN had the following goals and results, which contributed to achieving this overall objective, as foreseen by our Strategy.

Solidarity among women-led organizations in Kosovo enhanced

KWN's experience suggests that furthering and maintaining solidarity among women-led organizations is crucial towards building a sustainable women's movement, lest competition undermine efforts towards joint goals. KWN made progress towards achieving this outcome through the following expected results.



KWN members informed of other members' initiatives, KWN activities, funding opportunities and other useful information

KWN organized five bimonthly members' meetings through which 225 various members, partners, and supporters exchanged information; 36 joint initiatives were organized; and information about ongoing activities of KWN and other organizations were received. During meetings, the KWN members played an important role in collaborating to implement KWN's Strategy, as well as monitoring and evaluating KWN's work.



More young women activists involved in women's movement

KWN has posted and disseminated information on the Facebook page of FemACT trying to involve young women and men in various activities. KWN has offered practical work for four young women, while voluntary work for 23 young women. This has enabled them to become skilful in organization, research, advocacy, gender mainstreaming in advocacy for human rights and public relations, empowering women's skills of the Kosovo women's movement members.



Strengthened inter-ethnic understanding and cooperation among individuals and civil society groups in Kosovo and Serbia

In addition to building cooperation through regular KWN meetings and joint advocacy initiatives, KWN has provided opportunities for interethnic cooperation to organizations that received grants through the Kosovo Women's Fund and their beneficiaries. During this year our partner organizations Naš Dom (Our Home) & Women's Rural Development Center have been developing the initiative "Improving Local Policies from a Women's Perspective" as well as Open Doors & Ruka Ruci (Dora Dorës) organizations have developed Initiative: "Empowering Women Activists from the Community to Promote Women's Rights and Gender Equality through Participation, Information and Social Media".

Women in Black Network Serbia organised two-day regional workshop in Skopje during September, in the format of the workshop on the topic of peace, security and justice. During these two days, they discussed the continuation of the Women's Court for alternative justice for crimes committed against women during the 1990s.

Improved organizational capacity of KWN and its members towards long-term advocacy and sustainability of the network


A sustainable movement of women can not exist without its members who keep alive the movement. Therefore, KWN constantly supports its members in advancing their capacities. Workshops, mentoring sessions and the Kosovo Women's Fund have supported KWN members in advancing their organizations.

KWN, its members, and their work more visible to potential partners, women activists internationally and potential supporters

KWN regularly promoted the work of its members via the KWN website. Facebook page and monthly

e-newsletter Kosovar its

Women's Voice. KWN increased Facebook followers from 8.620 in 2016 to 16.498 in 2017. KWN's



'FemACT' Facebook

page

has 802 followers. KWN also manages the 'Lobi për Barazi Giinore' [Lobby for Gender Equality] page, which now has 1,864 followers. Also, KWN continues to use other social media, such as Twitter, for which the number of followers has increased from 594 to 647 and Instagram which saw an increase of followers from 669 to 1,101. This year the KWN website had 12,357 page views, 37,756 sessions and 24,495 users. KWN regularly wrote articles about KWN members in its monthly newsletter Kosovar

KWN has tried to have all publications and many of the information published on the Internet (often lacking translation funds) available in three languages: Albanian, English and Serbian.



More members better able to fundraise, plan effectively, run organizations and undertake effective advocacy initiatives

During this year, KWN through the Kosovo Women's Fund has allocated a total of 27 grants for its 31 member organisations. Of these, four Grants in Partnerships for Change (up to € 8,000) were allocated to 8 organizations that worked in partnership and 23 Individual Advocacy Grants (from € 3,000 to € 4,000) were allocated to organizations individually. "Partnership for Change" Grants have boosted cooperation among member organizations, enabling organizations from different regions of Kosovo to join forces and empower their initiatives by advocating together. For example, Medica Kosovo in partnership with the "Djepi i Buzqeshjes" carried out the initiative "Supporting the access of self-supporting mothers affected by war to agricultural subsidy programs" as a result of which up to now 10 women applied for subsidies from Gjakova Municipality, of which a woman benefited a greenhouse and motocultivators, six other women benefited moto cultivators as well as a woman received beehives and other accessories.

The main KWN supporters for this year were the Austrian Development Agency (ADA) and the European Union Office in Kosovo, which together contributed to the KWF in amount of € 99,842.35.

From the autumn of 2012 to 31 December 2017, as a result of the initiatives of various members, 19,564 persons, including persons with disabilities, persons from rural areas, persons of different ethnicities (Turks, Gorani, Serbs, Roma, Ashkali, Egyptians, Bosniaks and Albanians) young and retired, have benefited.



In 2017, KWN staff members provided 1,347 mentoring sessions to grantee beneficiaries from the KWF via e-mail, telephone and one-on-one meetings. The 7-member Grant Review Committee has also contributed to the advancement of the capabilities of members by

examining each application and providing practical advice. This has helped KWN members to submit better applications to the KWF and other donors.

Further on, by December 31, KWN members, supported by KWF, achieved the following results:

Ation for Mothers and Childdren launched the initiative "Advocacy for Extending the Information
Curriculum at the Women's Health Information Centers and staff training at the Center" by
advocating with representatives from the University of Prishtina, Faculty of Medicine, to establish
continuous cooperation between AMC and University through engagement of students in AMC
projects. Furthermore, through advocating for the Head of the Department of Maternal and Child.

Health at the Ministry of Health, postnatal depression was integrated into the education curriculum in the Classes for Mothers.

- "Psikoterapeutët në Veprim" carried out the initiative "Empowering Women Victims of Sexual Violence and Torture during the Kosovo Conflict in the Gjilan Region" through which 30 survivors of sexual violence were identified in the Gjilan Municipality. Advocacy meetings were also carried out by officials of local institutions as well as with officials of the Employment Office in Gjilan Municipality, wherein I I survived women of sexual violence were employed.
- Kosovar Gender Studies Center initiated the initiative "Gender Equality towards EU Membership" by
 advocating officials of the Ministry for European Integration and officials from the Municipality of
 Prizren. These meetings allowed raising the awareness on the application of gender sensitive policies.
 QKSGJ also drafted the guideline "Gender Equality in the Kosovo EU Membership Process Advocacy
 Guide", which the Ministry of European Integration and the Municipality of Prizren expressed their
 commitment to use this guide.
- Alpha Institute carried out the initiative "Protection of Human and Women Imprisoned in Kosovo Rights Through Their Socialisation" by holding 6 trainings with 20 women imprisoned in Lipjan Correctional Institution on topics such as: communication skills, conflict resolution skills, overcoming frustrations, stress and overcoming it, emotional processing, phobias and ways of overcoming them.
- Lawyers' Association Norma carried out the initiative "Empowering Women through Increasing Transparency of Institutions" where requests for review of closed property and inheritance cases in four basic courts in Prizren, Ferizaj, Podujeva and Gracanica were sent to the Kosovo Judicial

Council and the Chamber of Notaries. Based on these reviews, data, problems and difficulties faced by women during the realization of their property rights have been analyzed. Based on the data collected from the review, the report on the findings that was presented at the roundtable was compiled. In addition to these, 300 women and girls from the municipalities: Prizren, Ferizaj, Podujeva and Gracanica were informed regarding their property rights and inheritance.

- NGO Bliri carried out the initiative "Be part of and help prevent century diseases" by advocating at the
 Main Family Medicine Center in Drenas Municipality and providing gynecological services as well as
 free mammograms for 28 women and girls. In addition to this, 20 informative meetings were held
 during which 263 women and girls from the Municipality of Drenas were informed about their health
 rights and the importance of health care.
- NGO Rona carried out the initiative "Advocacy for the Empowerment of Women Farmers in Malisheva villages" through which 125 women from the Municipality of Malisheva became aware of their rights and opportunities for profit and financiar support for the development of households for agriculture. As a result of this iniciative, 11 women have taken the liberty to open small family businesses with the cultivation of medicinal plants as well as the processing of fruits and vegetables.
- Iniciativa e Grave Association carried out the initiative "Time for a New Political Spirit" by holding informative meetings in 5 villages of Dragash Municipality regarding the importance of women and girls participation in municipal decision-making processes wherein 150 women and girls from this Municipality attended. As a result of this initiative, 36 women and girls from this Municipality joined the various political parties.

- Handikos Mitrovica carried out the initiative "Empowering Women with Disabilities through Increasing Awareness on Their Property Rights". During this initiative, 8 informative meetings were organized, involving 100 members, namely persons with disabilities, from Mitrovica, Vushtrri and Skenderaj during which they were informed about their inheritance and property rights. Furthermore, 10 individual cases in individual sessions between the lawyer and members with disabilities were reviewed and analyzed, during which sessions the necessary documents for further proceedings for the realization of the right to inheritance and property were prepared.
- The "Krusha e Vogël" Women's Association carried out the initiative "Advancing Women and Girls in Rural Areas" by advocating the Directorate of Education, the Vocational Training Center, the Directorate of Economy and Rural Tourism, the Directorate of Agriculture and Rural Development and the Directorate of Social Welfare. During this initiative, training was also provided on the application for subsidies and other municipal and state support. As a result of this initiative, 4 of the training beneficiaries were employed at the milk collection point of this association. In addition to this, 8 women were registered at the Employment Office, of whom 2 were hired (hairdressing and accounting). Moreover, 2 women applied for subsidies (greenhouse) and 2 other women for agricultural means to the Directorate of Agriculture and Rural Development.
- NGO Foleja carried out the initiative "Raising the level of health education on the importance of family planning and reproductive health", through the advocacy with Director of the District Hospital of Prizren, the exemption from the payment for ultrasound gynecological and pap test services for 30 women of these communities has been provided. Furthermore, 16 trainings were

organized for 167 women and girls of the Roma, Ashkali and Egyptian communities from the villages of Prizren Municipality on reproductive health and its importance.

- Medica Kosova in partnership with the "Djepi i Buzqeshjes" Organization carried out the initiative "Supporting the access of self-supporting mothers affected by the war to agricultural subsidy programs" through which 20 trainings were held for 40 women, self-supporting mothers from the Municipality of Gjakova on opportunities and their rights to benefit from state subsidies. In addition to this, advocacy meetings with local institutions for women's benefit from agricultural subsidy programs were held. As a result of this initiative, 10 women applied for the benefit of subsidies from the Municipality of Gjakova from which a woman benefited a greenhouse and moto cultivators. In addition, 6 women benefited moto cultivators as well as woman receiving beehives and other accessories.
- Center for Protection and Rehabilitation of Women and Children "Liria" in partnership with "Legjenda" carried out the initiative "Raising the Position of Women in Peace Making Processes and Gender Budgeting". During this initiative, trainings were held with 41 officials from Ferizaj Municipality as well as Kllokot Municipality. In addition to the trainings, officials also gained knowledge through the exchange of experiences that were made with officials from Kamenica Municipality. As a result of this initiative, the Municipality of Ferizaj drafted the gender policies. This Municipality is now in the midterm framework planning phase as well as gender analysis in the unemployment sphere.
- Center for Art and Community "Artpolis" in partnership with the Center for Promotion of Women's Rights carried out the initiative "Recognizing and Promoting Reproductive Health Rights and Sexual

Education through Art and Engagement of Youths" during which awareness sessions were held as well as various activities wherein 130 women and girls from the municipalities of Pristina and Drenas became aware through art about reproductive health rights and sexual education. Partner organizations advocated with Ministry of Education, Science and Technology for introducing sexual education in curricula for secondary schools.

- "Gruaja Bashkëkohore" carried out the initiative "Health and Sexual and Reproductive Rights" by advocating with eight officials, representatives of local and central health institutions through public letters for the best implementation of the Law on Reproductive Health in Kosovo. They informed 75 girls, high school, primary school and various universities students regarding reproductive halth of women, sexuality, sexually transmitted diseases, abortion and early pregnancy.
- "ATO" Women's Association carried out the initiative "My Right to Property" by informing 85
 women and girls of Vushtrri Municipality on their rights to inheritance. Furthermore, four women
 started the procedure for registration of property in their name or joint ownership with their spouses.
- "Krusha e Vogël" Women's Association advocated with the Agriculture Directorate for allocating grants equally to women and men. This association trained 20 women and five men on how to apply for subsidies and support from the Municipality of Prizren, wherein 10 of these women prepared their applications for applying to the Agriculture Directorate in the forthcoming call. In addition to this, six women opened small family businesses with the support of this association.



• The Center for the Promotion of Women's Rights in partnership with the Center for Promotion of the Healthy Family carried out the initiative "Empowering Survivors of Sexual Violence during the War for the Realization of Legal Rights" by informing 120 women and men about specific rights, which are guaranteed by law (pension rights, housing and rehabilitation rights as well as education rights). Along with that, 120 women have been trained and are ready to complete the documentation for obtaining the status of civilian victims. At the same time, 50 personal stories of crimes during the war in Kosovo have been documented.

- The Association of Blind and Visually Impaired Persons developed the initiative "Awareness for Support of Blind People and Visually Impaired Persons" by successfully advocating the Directorate of Education, where four blind children joined the Special School for Blind People in Peja, and a child with visual impairment in primary education, as well as classrooms for the development of teaching courses for reading- writing according to the Braille alphabet. It has also been successfully advocated in the Urban Planning Directorate, where the road traffic for the blind is introduced in the urban plan for the following year. Further, 46 blind persons were informed about their rights in health, social and legal fields, and 50 family members of these persons were informed about the proper treatment of the blind and equal treatment with other family members.
- Partners Kosova developed the initiative "Women's Advocacy for Their Rights to Property and Inheritance" by informing 85 women and men about their property rights as well as the legal paths to be followed in cases of property division requests and inheritance. Eight monitorings.

sessions were carried out at the offices of the Registrar and Cadastre to see how many properties are being registered in the name of women and how much the legal deadline for property registration is respected.

- The Kosovo Blind Women's Committee (KBWC) held the initiative "More rights for blind women" by informing 20 women and men about their rights in education guaranteed by Law 04 / I - 092.
- Mitrovica Women Association for Human Rights developed the initiative "Women's decision-making" by informing and trainining 14 new candidates on leadership skills during the election campaign in October. Further, four new candidates from the 2017 election list, participants in these trainings became members of the municipal assembly in southern Mitrovica.
- Kosovo Center for Development and Multicultural Integration developed initiative "Economic Empowerment of Youth from the non-majority communities: Roma, Ashkali, Egyptian, with focus on Girls", where 29 Roma and Egyptian youth who had graduated from universities but were unemployed have been identified. These youngsters were offered the opportunity to attend various courses such as computer courses, English language courses, and courses for the speaking skills.
- Girls Coding Kosova held the initiative "#Walk Freely v.3.0. Cooperation with Kosovo Police" training 6 Kosovo Police, 6 officials from the Municipality of Prishtina and one official from the Emergency Agency of Kosovo on the use of the Walk Freely (EcShlire) application and the



harassment data reported through it. They have concluded an agreement with the Kosovo Police to use reports made through this phone application to investigate sexual harassment and to improve security. More, 26,500 people became aware of sexual harassment through the launch of a video in the media.

- Institute of Applied Psychology "Alpha" developed the initiative "Protection of human rights and of the rights of women imprisoned in Kosovo through their socializing (II)", offering training for 15 women imprisoned in Lipjan Correctional Institution. Training topics were such as: communication skills, conflict resolution skills, overcoming frustrations, stress and overcoming it, emotional processing, phobias and ways of overcoming them. As well, they also worked with 15 Correctional Institution staff of Lipjan and advocated for providing more opportunities for work and recreational activities for prisoners.
- Association for Education and Family Care concluded the initiative "An educated woman, a
 healthy society". They conducted 12 workshops with 230 women and girls from Gjakova
 Municipality, as well questionnaire has been conducted with young women regarding their health
 knowledge and access to healthcare services. Out of 230 women, 22 women and girls have
 performed free gynaecological visits. More, it was advocated to the Health Directorate in
 Gjakova Municipality to open a gynaecological information office for young women.
- Organization of Persons with Muscular Dystrophy of Kosovo developed initiative "Medical care
 is good when everyone has access to it" holding regular monthly meetings with 20 women, girls
 where were discussed different topics on the concerns and obstacles they have. Beside this, four

other meetings were organized, where health specialists held lectures. They have also compiled questionnaires that were designed for collection of more specific information on the primary health needs of persons with muscular dystrophy and needs of their family members. The information obtained served to come up with a more specific report and recommendations which were then submitted to local government institutions. They have advocated to all representatives of healthcare directorates, gender equality and local level institutions for improving access to health services.

- Vita Jeta undertook initiative "Diabetes in elderly", informing 284 women and 43 men on topics such as diabetes, food, therapy, hygiene of persons with diabetes, self-control. After each lecture, for all participants, glucose measurement was performed for the purpose of knowledge, monitoring and awareness of this disease. It was advocated to the Ministry of Health, the Directorate of Health and Social Welfare in the Municipality of Prishtina, to enable women and men to have an easier access to quality healthcare and in particular diabetes services.
- Centre for Women's Empowerment carried out initiative "Economic empowerment of women single mothers". They have advocated to officials and chairmen of the judicial council, court presidents, etc., asking for the examination of cases for alimony and property and addressing all the concerns and injustices that have been made to these women including their children. Also, it was released a storybook of women heads of households who sought the right to alimony and property. The book was written after 24 interviews with these women. Through these stories,



which are marked with initials to preserve identity, is created a clear picture of how court cases are handled and the problems faced on the way to court.

- Luna developed the initiative "Women's Health and Freedom of Movement" through which 68 women and girls were informed on breast and cervical cancer, about importance of self-examination and support for women affected by these diseases. Individual consultations on their health problems were offered too. More, they have also advocated for providing of the gynaecological services to the Family Medicine Centres of the villages as: Prilluze, Plemetin and Gojebule. They have also advocated to Municipality of Vushtrri, Ministry of Infrastructure and to Ministry for Communities and Returnees for arranging the transport line which will pass through these villages
- Together in Progress concluded the initiative "From Mothers Advocacy for women farmers of the Municipality of Gjakova". During this initiative three focus groups were organized with the following topics: I) Empowering the livestock/agricultural economy; 2) Empowering and assisting women with livestock economy by public institutions; and 3) Subsidizing opportunities for these businesses, where participated women project beneficiaries, civil society representatives, officials, whom worked together to give recommendations in order to provide women farmers with a space to sell their products. Were realized the request of women farmers for the use of the Namasgjah space free of charge or at a very symbolic amount.
- Initiative for Integration of Communities developed the initiative "Improving women and girls position through their involvement in the decision-making process in the Municipality of Dragash",

- informing 33 women related to their property and inheritance rights, and importance of their participation in political processes such as decision-making. Beside that 4 women who had applied for municipal advisor of the Municipality of Dragash, were employed.
- Lulishtja (Graden Flowers) conducted the initiative "Promotion of women's rights and empowerment of their role in probate proceedings", informing 215 women and 5 men from 20 villages of Prishtina and Podujeva municipality related to their property and inheritance rights. As well, legal assistance was offered for women who needed more detailed information.
- NGO Bliri Raising developed the initiative "Raising youth awareness about reproductive health", where they informed 400 secondary school students on topics such as: Health Care, Prevention of Sexually Transmitted Diseases, as well as for phenomena of the Century such as AIDS, Drugs and Smoking. Information sessions with 400 women and girls on diseases such as breast and cervical cancer have been held. Has been successfully advocated to local health institutions for free-of-charge gynaecological visits and services.
 15 women, through this initiative, have performed free gynaecological services.
- Divine Woman developed the initiative "Raising the awareness of citizens about the women's right to inheritance". Eight different workshops were organized involving women and girls of age 25-55, with purpose of raising participants' knowledge of local laws that guarantee gender equality, with particular focus on the importance of inheritance and property rights, including property and inheritance legislation. In addition, there were also working groups in the villages of Breslac, Velekinka and Malisheva. In order to ensure that the recommendations emerged from

these workshops will be implemented, advocacy meetings with representatives of the Municipality of Gjilan, the Office for Gender Equality and the Directorate for Registration and Cadastre from the same municipality were also organized within this project.

- Social Club Live conducted the initiative "Easier access of women to justice in cases of property disagreements or disputes", by organizing I3 presentations in communities and in different schools from Deçan, Junik, Gjakova and Pristina regions. Also, there were some awareness raising campaigns, roundtables, trainings, and seminars, which purpose was promoting human rights, enhancing social welfare and improving living conditions, increasing participation in social and economic life for all age groups. In total, 129 participants benefited from this project, out of which I13 were women and I6 men. It was advocated to the Ministry of Labour and Social Welfare and Centers for Social Work in the municipalities of Junik, Deçan and Gjakova. Representatives of these institutions were informed about the importance of mediation so that women and girls could have the opportunity to express their will, to decide on their own dispute, to be able to be equal with the other party as part of the procedure and were informed about the work of Mediation Offices in 7 regions of Kosovo.
- Handikos Mitrovica developed the initiative "Easier access of woman and girls with disabilities to
 health care", by organizing 8 informative meetings with 98 members of this organization regarding
 to their rights to healthcare. Also, 10 individual sessions were organized between beneficiaries
 and the doctor, where they received medical guidance as per certain health issues. Also, advocacy



- meetings have been organized with project beneficiaries and local health institutions, where they advocated for providing better health services for people with disabilities.
- Education Code conducted the initiative "Entrepreneur women", where 36 women running small businesses held trainings on topics: creating and developing micro businesses; problems faced by women in business and overcoming them; and the impact of property issues on the business activities of women. In addition, staff organized visits and advisory sessions to support beneficiaries with their businesses. It was successfully advocated to the Ministry of Economic Development, signing memoranda of understanding to increase the number of trainings, mentoring sessions and support for women entrepreneurs. They also signed a Memorandum of Understanding with MAFRD to organize information and advisory sessions in the municipalities of Fushe Kosova, Obiliq and Gracanica, prior to grant schemes and subsidies, so that women entrepreneurs from target municipalities can be informed about ways of further developing agricultural and artisanal small businesses.
- Rikotta & Women's Association "Gora" developed the initiative "Make yourself aware that your health is important for the society". I 20 Gorani, Torbesh and Serb women from villages of the Municipality of Prevallac were informed on topics as: Transmissible Sexual Infections, Contemporary Family Planning Methods, HIV / AIDS, Usage of Contraceptives, Health Services provided at FMCs in this case in Prizren, as well as Malignant Diseases breast and cervical cancer. It was successfully advocated to the Municipality of Prevalla, Ministry of Justice, to the Health Directorate of the Municipal Assembly of Prizren and the Institute of Public Health, where

enabled women to have free visits to a gynaecologist and different check ups in the family medicine center in Recan.

- Naš Dom (Our Home) & Women's Center for Rural Development undertook the initiative "Improving of local policies from the women's' perspective", where 31 women from Albanian and Serbian communities were trained on topics such as: raising women's awareness about the importance of their participation in decision-making processes; and creating better relations and communication between the holders of rights and persons exercising them. In addition, an informal inter-municipal body was set up, and it created a working document with the priorities of women coming from these three municipalities: Gjilan, Novoberde and Kamenice. Through this document, the informal group advocated to local institutions to adopt recommendations from this document.
- Dera e Hapur (Open Door) & Ruka Ruci developed initiative "Empowering Women Activists from the Community to Promote Women's Rights and Gender Equality through Participation, Information and Social Media" They trained 22 Albanian and Serbian women on topics such as: using the internet, sharing stories, showcasing issues, proposing solutions, women and social security, self-care, privacy, internet activism and use of social media. In addition, 400 women participated in a set of two workshops where women were informed about ways women could be more active in decision-making, raising their voices through different campaigning initiatives.

Annex I contains a list of all grants allocted by KWF in 2017 and their achievements.

KWN staff capacities increased

KWN, during 2017, has continued to provide opportunities for its staff members to increase their capacities:

- I) In April, Gentiana Murati, Kosovo Women's Fund Coordinator, attended a study visit to Bosnia and Herzegovina (BiH). Kvinna till Kvinna Foundation (KtK), at the same time the organizer of this study visit, gathered in Bosnia and Herzegovina eight organizations from Kosovo and eight organizations from Bosnia to share the experience, lessons and challenges faced by women's rights organizations.
- 2) Iliriana Banjska, Gender Analyst, attended several advocacy meetings in Brussels organized by KtK in April, which resulted in improved advocacy skills at the European level.
- 3) In May of this year, KtK organized a study visit to Stockholm, Sweden, where Adelina Berisha, Coordinator for Advocacy and Research participated. She had the opportunity to be closely acquainted with the work Sweden is doing in fighting violence against women and girls. Also, this was a good way to network with other organizations in the region and to exhange information.
- 4) In September, also under the organization of KtK, Adelina Berisha visited Vienna, Austria. This study visit was intended to raise the advocacy capacities of participants in fighting violence against women and girls.
- 5) Miranda Avdullahu, Project Assistant for Gender Responsive Budgeting, participated in the Sustainable Urban Mobility Planning Workshop for Prishtina organized by the Municipality of Prishtina and at the Workshop on Gender Mainstreaming in Culture and Art within the FemArt.



- 6) Mirjeta Dibrani, Grants Assistant at KWF, participated in the workshop "Gender Equality", organized by the Kosovo Institute for Public Administration. She also participated in a workshop organized by KtK in Tirana, for partner organizations regarding Monitoring and Evaluation of Projects.
- 7) Gresa Rrahmani, Legal Advisor, participated as the organizer of the Dialogue Caravan financially supported by OSCE in Kosovo. This caravan traveled through various municipalities of Kosovo and Serbia, encouraging discussions about women's rights and organizing workshops to improve their situation. The caravan implemented by young women from both countries also served as a bridge of cooperation, dialogue and peace-building.
- 8) In April, Nertila Qarri Gërguri, Project Coordinator participated in the "Training on Gender Perspective in European Union" organized by Austrian Development Cooperation (ADC) for the staff of the Austrian Development Agency (ADA) and all ADA partners in Kosovo. Further, during May, she also participated in the workshop on "Social Standards" organized by ADC/ADA. Meanwhile, in July, she attended the workshop "Integrating Human Rights Approach (HRD) in Higher Education" organized by the HERAS Project.
- 9) Alba Loxha, Public Relations Coordinator was part of a workshop on recent trends and developments in the media and social networks organized by KtK Foundation in Pristina.
- 10) Based on their responsibilities, KWN staff members have received on-the-job training related to: gender responsive budgeting, budget analysis, interviewing skills, writing of concept papers, advocacy strategy writing, reporting writing, monitoring and assessment, research methods, sample selection, public speaking skills, and sharing of documents on the Internet.

11) Some KWN members have been mentored during the work.

The funding climate for women's rights organizations improved

Although some advocacy initiatives can be taken on a voluntary basis, women-led Civil Society Organizations (CSOs) still need different resources in many aspects of their important work.

On 22 November, organized by the European Parliament (EP), in cooperation with the "Kvinna till Kvinna" Foundation, the KWN participated in three panels focusing on: I) Integrating gender and women's rights issues in the EU membership process: examples from progress reports for the countries; II) social reforms, including maternity leave: who benefits? and EU funding for women's organizations; and III) what are the challenges and opportunities?. KWN, among others, highlighted the important role the women's rights organizations have in making sustainable change within their communities as well as the importance for the needs of women's rights organizations for funds and various types of funding modalities to communicate/reach at various organizations.

Sustainable women's rights activism requires resources and KWN will continue its efforts to mobilize sufficient resources from local and international actors to support women's movement in Kosovo and beyond.



Institutional and public awareness about the importance of tax deductions for supporting the important work of women's rights groups improved KWN will engage in this issue in the coming years.

KWN Fundraising Plan implemented

KWN continued fundraising in 2017 and managed to provide the most of the resources required for making progress in implementing the strategy for the next year.

WOMEN IN POLITICS AND DECISION-MAKING

The long-term objective of this program is that women participate actively in politics and decision-making at municipal and central levels. KWN has made progress towards achieving this objective as the following outcomes and results illustrate.

Women's participation in politics and decision-making at municipal and national levels increased and improved as per the Law on Gender Equality

If women are to participate actively in politics and decision-making at municipal and national levels, the number of women participating and the quality of their participation must be improved. Towards, *KOSO(I/A)

achieving this objective, 599 diverse women citizens participated in politics and decision-making processes via KWF initiatives during 2017. At the same time, the quality of participation has improved, demonstrated by the issues discussed between women and officials through this action. KWN made progress towards this outcome through the following results in 2017.

Contract of the Contract of the

Gender Equality Advocacy Groups (GEAGs) established and functioning in 27 municipalities and at the national level

In 2014, GEAG members established the Kosovo Lobby for Gender Equality (KLGE). Members decided that men and boys who support equal rights for women and men also can join this group. At present, Lobby groups exist in 27 municipalities.

On 4 March 2017, Kosovo Women's Network (KWN) in cooperation with women from Mitrovica, at the same time the hosts of this meeting, organized the Lobby for Gender Equality meeting in Kosovo. The topic of this meeting was "Advocacy Strategies for 2017". 69 women and girls participated in this meeting, including gender equality officers, assembly members and representatives of KWN member organizations from different municipalities of Kosovo and members of KWN staff.

On 20 May, in Mamusha, 66 members of Lobby, representatives of local institutions, international organizations and staff members of Kosovo Women's Network (KWN) staff participated at the next meeting of the Lobby on Gender Equality in Kosovo. In this meeting the International Organization of National Democratic Institute (NDI) was also provided a space, namely the activities of the Women's Academy for Leadership, which is a continuation of the "Week of Women" activity.

Women participants of the Academy divided into four thematic groups: I. Economy, 2. Health, 3. Education and 4. The role of women in decision-making positions, received dozens of recommendations from members of Lobby, then included in the platform of concrete proposals for the leadership of the political parties.

On 8 September, in Deçan, was held the next meeting of the Lobby for Gender Equality in Kosovo, attended by 104 members of the Lobby, representatives of local institutions, international organizations and members of the Kosovo Women's Network (KWN) staff, where guests of honor were also Mrs. Atifete lahjaga, former President of the Republic of Kosovo and Mrs. Alexandra Papadopoulou, Head of EULEX Mission in Kosovo. During this meeting, the Lobby members presented the advocacy initiatives they have taken in their municipalities until May, as well as the advocacy initiatives they plan to take by the end of the year.

During the period 24-26 November, in Durrës, was held the three-day Lobby for Gender Equality in Kosovo attended by over members of Lobby, representatives of local institutions and members of Kosovo Women's Network staff (KWN). The main purpose of this meeting was the networking, solidarity and exchange of experiences of municipal representatives with each other, thus creating co-operation between them to improve the position of women and girls in respective municipalities. from the **Apart**



presentation of advocacy initiatives taken in this period, the members of Lobby also presented three main points for which they will be committed to work during 2018.

Some of the planned advocacy initiatives are: to advocate for young girls for engagement in politics and their empowerment in political entities; to advocate for equal division in managerial positions; to advocate for employment and housing for self-supporting mothers; to advocate for the economic

empowerment of women through subsidies in municipalities; to advocate for problem solving in better quality approach to health services for women; to advocate for scholarships or other issues of importance for the education of girls and women; etc.

At this meeting of the Lobby were also present the representatives of NDI, where the purpose of the presence of NDI at this meeting was to hear the voices of women on the issues they think are important to be presented during the Women's Week in 2018.

Capacities of women in politics to advocate for women's priorities furthered

The abovementioned Lobby meetings also further developed the women's capacity in politics to advocate for women's priorities by providing examples of best practices and improving their advocacy skills.

During this year, KWN Executive Director, Igballe Rogova, held 284 mentoring sessions with the Lobby groups throughout Kosovo. These sessions served to strengthen the Lobby members in their advocacy for women's rights and gender equality through visits to their municipalities or through telephone calls. It is important to note that KWN does not see or treat members of Lobby as members of political parties, but rather as leaders in their municipalities. The KWN Executive Director also was present at their events, promoted their initiatives, supported them in their advocacy initiatives by joining them in meetings with local officials on various issues and assisted them in overcoming the problems that have occurred in their planned advocacy towards gender equality.

The initiatives taken by 31 beneficiary grants supported by the KWF by 31 December 2017 included 398 women in decision-making processes, such as through meetings with local authorities and advocacy. For some women, this was the first time they were involved in decision-making processes.

Within institutionalization framework of GRB, the KWN has trained and mentored 17 officials in the Ministry of Agriculture, Forestry and Rural Development (MAFRD), 13 in the Ministry of Diaspora (MoD) and 15 in the Municipality of Prishtina regarding the inclusion of RGB in the process of budget planning. This can contribute to budget planning that will better serve the needs and priorities of women.

As a result of previous meetings with GEOs and based on the lessons learned from their experiences, KWN has drafted the new curriculum for GEOs. This has become part of the curriculum implemented by the Kosovo Institute for Public Administration (KIPA).

Awareness of the importance of aligning the Law on Gender Equality and electoral laws enhanced

This year, KWN continued to advocate on the importance of aligning the Law on Gender Equality with the current electoral laws. This was done through publication of the policy document <u>Kosovo's Progress in the Approximation of its Laws with EU Laws on Gender Equality</u>, written by two well-known European lawyers and gender equality experts, Sylvia Cleff le Divellec and Katharina Miller, at the request of KWN, which they published on 8 November. The document assessed the extent to which Kosovo's laws are aligned with the Acquis on Gender Equality of the <u>European Union (EU)</u>. The

experts have identified shortcomings and have given recommendations for better harmonization of Kosovo's laws with the EU's Acquis on Gender Equality. Some of the key recommendations include:

- Kosovo should regularly collect data on the wage gap in order to facilitate its monitoring;
- The Labor Law requires some changes to meet EU standards;

- Specific definitions of sexual harassment and domestic violence should be included in Criminal Code; and
- Sanctions in the <u>Law on Gender Equality</u> are not sufficiently severe to prevent violations of the Law and are therefore not sufficiently convincing, as envisaged by the EU Gender Equality Acquis.

The implementation of the Law on Gender Equality remains weak and further steps should be taken as recommended in the Policy Paper to address this.

Women in politics, women-led organizations and women voters communicate and cooperate more around issues women consider priorities

Through Lobby and KWN members, women from political sphere, civil society and women voters have all collaborated around issues of importance to them in 2017. The Lobby in close cooperation with women voters from their municipalities advocated on issues women consider priorities this year.



Advocacy initiated on issues women consider priorities

In 2017, KWN has advocated in many political processes and policies on women's priorities. The KWN has participated in a number of government working groups and/or has provided comments on the laws and policies that will affect the lives of women and girls. KWN has supported gender mainstreaming by analyzing public policy drafts (laws, administrative guidelines, strategies, action plans) from a gender perspective and assessing the potential impact they may have on men, women, girls and boys. Policies that KWN reconsidered in 2017 from a gender perspektive, and provided data included:

- Matrix of the National Program for the Implementation of the Stabilization and Association Agreement (NPISAA) for 2017
- 2. Draft National Action Plan on the Rights of Persons with Disabilities 2017-2019
- 3. Draft Law on Amending and Supplementing the Law No. 02/L-249 on Health Insurance
- 4. Draft Code of Conduct for the Kosovo Security Force (MKSF) Nr.02 / 2017
- 5. Draft Regulation on NGO public funding criteria, standards and procedures
- 6. European Commission Report on Kosovo for 2018 (*Progress Report on Kosovo*)
- 7. Amendments to the Draft Criminal Code of Kosovo
- 8. Drafting Kosovo Gender Equality Program 2017-2021 of the Agency for Gender Equality in Kosovo
- 9. Harmonisation of Labor Law with FU Directives.



Through KWF, KWN has also supported 61 advocacy initiatives by twelve KWN members, detailed in the previous section of this report.

Institutionalization of Gender Responsive Budgeting in Kosovo improved

" he then the works

Gender Responsive Budgeting (GRB) is important not only for women's increased and improved participation in decision-making but also for the efficient and equitable distribution of public funds. Therefore, KWN is based on past positive experiences, using the method developed by GIZ and international expertise, to work towards the institutionalization of gender responsive budgeting in Kosovo.



Capacities of targeted officials for carrying out GRB improved

In 2017, two ministries and one municipality were assisted by KWN to incorporate GRB in their budget planning process. In total 45 officials in central and local level were trained and mentored. People trained and/or mentored include finance officers, heads of finance in municipal directorates, general secretaries of ministries, representatives of ministerial departments, divisions, and agencies as well as GEOs, who have gained new knowledge and capacities. Of the 45 officials, 17 (16 women and 1 man) were mentored and trained at the Ministry of Agriculture, Forestry and Rural Development (MAFRD), 13 (6 women and 7 men) at the Ministry of Diaspora. While in the municipality of Pristina were trained 15 officials. 7 women and 8 men.



Also, supported by the KWF, the Center for the Protection and Rehabilitation of Women and Children "Liria" held the initiative "Raising the Position of Women in Peace Making Processes and Gender Budgeting" by training 41 officials from Ferizaj and Kllokot Municipality. In addition to the trainings, officials also gained knowledge through the exchange of experiences that were made with officials from Kamenica municipality. As a result of this initiative, the municipality of Ferizaj made the drafting of gender policies. This municipality is now in the mid-term planning phase as well as gender analysis in the unemployment area.

Concrete recommendations for improved gender responsive budgeting presented to relevant officials towards institutionalizing GRB

Due to KWN's advocacy and mentoring, the following successes were achieved towards institutionalizing GRB:

Based on the support that KWN has offered to the Ministry of Agriculture, Forestry and Rural Development and the Ministry of Diaspora to include a gender perspective in the Mid-Term Expenditure Framework (MTEF), both Ministries have integrated all the proposed changes from KWN into this important document budget.

In addition, during the publication of reports on the gender analysis of the budget and expenditures of the Ministry of Agriculture, Forestry and Rural Development and the Ministry of Diaspora and Strategic Investments, the recommendations emerged from the report were presented in the presence of a diverse public, including national and oficial media of the relevant ministries. The recommendations were welcomed by representatives of both ministries.

In addition, updated versions of RGB brochures have been published, which have been started to be used by the Kosovo Institute for Public Administration in a new curriculum for civil servants related to RGB - 'Practical User Guide: Responsive gender budgeting at the local level' and 'Practical user guide: Gender-responsive budgeting at central level'.



IMPROVING WOMEN'S ACCESS TO QUALITY HEALTHCARE

The long-term objective of this program is that 'women have access to and are accessing affordable, quality healthcare'. KWN has made progress towards achieving this objective as the following outcomes and results illustrate.

Public officials and health institutions held more accountable for addressing violations of women's right to healthcare

In February this year, KWN published the report "Access to Health Care in Kosovo". Following the publication of this report, KWN together with the members established the Health Advocacy Group (HAG). Several meetings with members of the group have been held, where the areas where they will be advocated are also divided. Part of this group are: KWN, Kosovo Midwives Association, Women Initiative Association and Gender Equality Officer at the Ministry of Health.

Meanwhile, in October, members of HAG met with the newly appointed Minister of Health, Uran Ismaili, where the maternity closures in the municipalities and the negative impact it has on the access of women to health care was discussed; the importance of midwifery in providing health services in maternity and the definition of midwifery job descriptions; and the proximity of the community with healthcare providers through decentralization.




Women and girls more aware of their right to healthcare and the importance of accessing healthcare; More women are aware of how to detect cancer signs

Supported by the KWF, Gruaja Bashkëkohore (Modern Woman) raised the awareness of 52 women and girls, Foleja 300 women and girls as well as Action for Mothers and Children raised awareness of 263 women and girls in the Prizren municipality, the Association of the Blind and Visually Impaired Persons at 59 Blind Persons and 40 Family Members in Rahovec Municipality; and Bliri organization in 263 women and girls in the municipality of Drenas (for more information see the section above "KWN Capacity Building").

Health research documenting violations of women's right to healthcare exists

In 2016, KWN conducted a research on Kosovo's citizens access to health care. The report was published in February 2017, entitled "Access to Health Care in Kosovo", where it was documented that women in rural areas face more than men or women in urban areas, with financial, cultural, and patient-service-provider relationships barriers in access to the health service. Bosniak and Turkish women have more tendency to deal with obstacles than men of the same ethnicity, and considerably more than Albanian women and men. Roma, Ashkali, Egyptians, and Gorani women and men are faced with obstacles, financial and cultural access in health care

The main purpose of this research has been to investigate what barriers exist in accessing health care and whether they are different for men and women. More than 1,300 people were surveyed as a part of the survey conducted in the summer of 2016 and 109 health workers and key experts were interviewed. Students from the College of Dartmouth, the University of Prishtina and many national and international volunteers have helped field work and analysis.

More public officials, women, girls and men are aware of women's right to health care and violations of their rights

KWN, this year continues to be a member of the K10 Coalition for Health and Reproductive Rights. During this year was drafted the Advocacy Strategy of this Coalition. Also, some open discussion with citizens on various topics related to reproductive rights and reproductive health have been held.

K10 Coalition was established in 2015, and consists of KWN, Action for Mothers and Children; Association for Education and Development of Health; Artpolis; Health for All; Kosovo Center for Fighting Breast Cancer – Jeta Vita; Kosovo Fund for Population; Kosovo Association for the Promotion, Advancement and Protection of Adolescent Health; Peer Education Network; and the Patients' Rights Association in Kosovo.



More women to have access to quality health care

As a result of initiatives supported by the KWF, Bliri successfully advocated to the Main Family Medicine Center in Drenas municipality and provided free gynecological and mammography services for 28 women. Likewise, Foleja successfully advocated at the Main Family Medicine Center in Prizren Municipality and provided free gynecological services for 30 women of the Roma community.

HAG has successfully advocated in the Ministry of Health for: Closure of maternity wards in the municipalities and the negative impact it has on women's access to healthcare; The importance of



midwifery in the provision of health services in maternity and the definition of midwifery job descriptions; and community proximity to healthcare providers through decentralization.



Women and girls more aware of their right to healthcare and the importance of accessing healthcare

On 28 October, Kosovo Centre for Fighting Breast Cancer (KCFBC) Jeta-Vita, organized their traditional, cultural and information program, gathering hundreds of citizens, including KWN staff members and other organizations, along with high state representatives, who marched together with the motto of the organization 'early detection equals survival', to express solidarity and raise awareness of cancer of the breast in Kosovo society.

Supported by the KWF, to inform women and girls more about their rights, KWN member organizations took these initiatives: Gruaja Bashkohore



informed 52 women and girls from the Municipality of Prizren; Association for Education and Care of the Family 230 women and girls from the municipality of Gjakova; whereas Bliri 263 women and girls from the municipality of Drenas; Action for Mothers and Children worked in the municipality of Prizren informing 48 girls from the municipality of Prizren; as well as Foleja in Prizren municipality informed 167 women and girls. Artpolis organization in partnership with the Center for Promotion of Women's Rights organized awareness sessions for 130 women and girls from the municipalities of Prishtina and Drenas.

More women advocate for their rights to quality health care

With the support of the KWF, seventeen advocacy initiatives were taken by KWN member organizations: Gruaja Bashkëkohore advocated the Ministry of Health through a public letter to Minister Uran Ismaili. The request contained recommendations for improving the access to health for women and girls in Prizren municipality, deriving from the activities and tables implemented by this association. The Association for Education and Family Care advocated for the opening of a health advisory office for girls in the municipality of Gjakova.

Bliri advocated successfully at the Main Family Medicine Center in Drenas municipality and provided gynecological services as well as free mammography. Artpolis in partnership with the Women's Rights Promotion Center advocated at the Ministry of Education, Science and Technology for the introduction of sexual education in secondary education curricula. Action for Mothers and Children, successfully advocated the opening of the "Classes for Mothers" within the Main Family Medicine Center in Prizren. They also advocated introducing the topic of postpartum depression in the Educational Curriculum in the Classes for Mothers. Foleja promoted successfully to the Main Family Medicine Center in Prizren Municipality and provided free gynecological services.



A LIFE FREE FROM GENDER-BASED VIOLENCE

The long-term objective of this program is that women and girls live a life free from gender-based violence. KWN has made progress towards achieving this objective as the following outcomes and results illustrate.

Implementation of the domestic violence legal framework, including institutional response in assisting persons who suffered violence, improved

By the end of 2016, the Ministry of Justice established the working group, which drafted the Strategy and Action Plan for Protection from Domestic Violence 2016-2020. This strategy was published in May and included over 70% of KWN's report recommendations "No More Excuses". During this year KWN has collaborated with the Balkan Investigative Reporting Network (BIRN) to monitor the implementation of the legal framework for domestic violence.

In this year, KWN has also helped the family of the deceased Zejnepe Berisha who was killed by her husband as a result of domestic violence. The assassin was sentenced to a minimum sentence, therefore KWN engaged a lawyer to help the family of the deceased, whereby the killer from the original 12-year sentence was sentenced to 17 years in prison.

This year, KWN also continues to be part of the Gender Security Group, a group composed of numerous stakeholders with whom KWN has co-operated in advocacy to improve the implementation

of the relevant legal framework. This includes advocating for the implementation of the Strategy and National Plan for Protection from Domestic Violence 2016-2020.

KWN has been invited by the European Parliament Committee on Women's Rights and Gender Equality (FEMM) and the Subcommittee on Human Rights (DROI), where it advocated support from EU parliamentarians in order to ensure that treatment of violence against women, in all its forms, becomes a political priority.

In September this year KWN sent a proposal for inclusion of domestic violence and sexual harassment as separate criminal offenses in the Criminal Code of Kosovo.

Follow-up monitoring reports exist on the implementation of the domestic violence legal framework, as well as awareness about extent of domestic violence

KWN has continued its efforts to raise awareness among citizens in reporting domestic violence and the legal framework that helps them address domestic violence. During this year, in cooperation with BIRN, KWN monitored 179 reported cases of domestic violence in local institutions, including: Police, Center for Social Work, Prosecution, Courts and Victim Advocates, in 7 regions of Kosovo. During this monitoring it is seen that in general there is improvement of some institutions in the implementation of the legal framework.

Further, during this year, KWN interviewed over 80 representatives of these institutions to see closely how addressing cases of gender-based violence has improved. The research report will be published in January 2018.

Institutions and other actors aware of the extent to which the domestic violence legal framework has been implemented

During this year too, KWN held meetings with representatives of institutions to advocate regarding the implementation of the legal framework related to domestic violence. Meetings were held with prosecutors, the Police Directorate, the Department of Social Work in MLSW, the head of the Office for Protection and Assistance of Victims and other relevant stakeholders. These meetings were intended to support institutions in improving their work in applying the legal framework for domestic violence.

KWN members engaged in the implementation of the legal framework on domestic violence

KWN has constantly cooperated with some of its members, in addition to other stakeholders, in advocating for the implementation of the legal framework. KWN will continue to involve more members in this advocacy.

In addition, some KWN members were involved in advocating for the implementation of the legal framework throughout their municipalities, particularly during the 16 Days against Violence against Women.



Performance and quality of services of shelters enhanced, particularly towards rehabilitation and reintegration

KWN will continue to advocate for sustainable funding for shelters both at the central and local level, as well as to improve the quality of service monitoring.

Awareness and attention regarding the treatment of gender-based violence among officials and citizens has been improved, including domestic violence, rape and sexual harassment

Progress has been achieved as shown in the following results.

More citizens informed about the legal framework and their rights, including men

KWN has had more than 116 appearances in written, TV and social media platforms, in order to distribute messages on domestic violence and raise awareness among citizens and officials of the domestic violations.

During this year, KWN has also started the campaign "No More Excuses" (#NoMoreExcuses) on social media (Facebook, Instagram and Twitter) in order to raise awareness of various forms of domestic violence as well as on the ways of reporting domestic violence and sexual harassment.



Improved policies and procedures for addressing sexual harassment exist

KWN has submitted an amendment proposal to include sexual harassment as a separate criminal offense within the amendments to the Criminal Code. This proposal aims at improving the procedure and treatment of sexual harassment in accordance with the seriousness and severity of this offense. In addition, KWN's written comments to explicitly include sexual harassment in the Code of Conduct for the Kosovo Security Force have been accepted and included in the Code.

The Artpolis organization compiled the Policy Handbook for Addressing Sexual Harassment at Public Universities. Also, the Kosovar Gender Studies Center has drafted "Policies against Sexual Harassment at Work in Kosovo"

Coordination established among women-led CSOs, public institutions and other workplaces towards installing improved mechanisms for reporting and investigating cases of sexual harassment

The work of Artpolis with public universities is seeking to improve their response to sexual harassment. Also, the policy drafted by the NSCC contributes to the protection of gender equality as a fundamental value of the democratic development of society in Kosovo by banning any form of sexual harassment that endangers the personal integrity of all employees in Kosovo.



KWN in cooperation with Girls Coding Kosova held trainings for the police, spatial planning directorate and the Office for Gender Equality of the Municipality of Prishtina regarding the use of the "Ec Shlirë" platform and the local legal framework related to sexual harassment, to improve the reporting and investigation of cases of sexual harassment.

Institutional and public support for persons who suffered sexual violence during the war improved

KWN has remained an active member of the working group formed by MLSW as a successor to the National Council of Presidents for Survivors of Sexual Violence during the War. KWN has also continued with its advocacy regarding the establishment of an official Commission that will review applications for compensation and government support for surviving women as well as its Secretariat.



Throughout 2017, KWN participated in co-ordinated meetings of MLSW with organizations working to support survivors who suffered sexual violence during the war. These regular MLSW meetings have enabled co-ordination between organizations and the process of recognizing and verifying the status of victims of sexual violence during the war.

At the conference organized by the Kosovo Center for Rehabilitation of Victims of Torture (KRCT) on "Treatment of the Stigma for the Survivors of Sexual Violence during the Kosovo War" on 14-15 September 2017, KWN along with KRCT, Medica Kosova, Medica Gjakova and the Women's Rights Promotion Center (WRPC) concluded that the urgent issue regarding survivors of sexual violence during the war is the approval of the budget to continue to provide compensation for survivors of sexual violence during the war. Therefore, these

organizations wrote a joint letter to address the issue, urging the Government to proceed with the approval of the budget. This advocacy initiative was successful as at the +meeting of 22 September, the Government of the Republic of Kosovo approved budget review for 2017, allocating the budget for the process of recognizing and verifying the status of survivors of sexual violence during the Kosovo war. Now, the pension for these women will be 230 euros a month and the application period for them will begin in January 2018.



KWN and its members involved in processes towards ensuring institutional and public support for persons who suffered sexual violence during the war improved

During 2017, KWN contributed to the economic empowerment of survivors of sexual violence during the war through the project "Supporting Survivors of Sexual Violence", which was supported by UN Women as part of their Global Project "Gender Sensitivity in Justice in transition", funded by the European Union (EU).

Through this project KWN allocated a total of € 180,487.46 for the four KWN member organizations specialized in working with surviving women of sexual violence during the war: 1. Medica Gjakova; 2. Medica Kosova; 3. Kosovar Rehabilitation Center for Torture Victims (KRCT); and 4. Women's Rights Promotion Center (WRPC). These organizations then allocated micro-grants for 177 surviving women of sexual violence during the war, as well as psychological support. Through this project, KWN in coordination with these 4 member organizations offered joint advocacy to represent their interests more widely to government officials and citizens; and regular coordination of key actors working to support women survivors of sexual violence during the war.



FURTHERING WOMEN'S ECONOMIC EMPOWERMENT

The long-term goal of this program is: women and men have equal economic opportunities at home and in the public sphere.

More women secure employment

KWN made progress towards this long-term objective that women have equal access to employment opportunities in Kosovo. A great achievement in this direction is the establishment of the Women's Economic Forum and its involvement in the Economic Development National Council of Kosovo in 2017. KWN as co-founder of this Forum, has taken concrete steps toward the creation of a comprehensive advocacy strategy which aims to improve some key policies for the employment of women in Kosovo.

KWN, this year as well, has been part of the working group on amending the Law on Labour, advocating especially on amending the articles of this law related to maternity leave, breastfeeding and making a provision that sets out a joint parental leave.

Institutions and key actors more aware of the extent of genderdiscrimination in the workplace in Kosovo and ways to address it and further institutional and private sector capacities for placing women in jobs

KWN as part of advocacy activities during the process of amending the Law on Labour (see above), athrough fruitful discussions has managed to raise awareness of the representatives of the institutions

and diverse private sectors in relation to gender discrimination at the workplace and employment of women.

More affordable childcare opportunities available

In 2016, KWN in cooperation with Swiss Contact PPSE program launched the report "Who cares?", wherein several alternative forms of opportunities for childcare for elderly care were presented. As a result of this cooperation, PPSE awarded grants supportive to NGOs, aiming to increase alternative options of childcare and elderly care. Among the beneficiaries was also the KWN member organization SHE-ERA, which has trained 3 men and 87 women who acquired knowledge about the childcare and the elderly care. This project aims to contribute in creating employment opportunities for women and to facilitate women in sharing the burden of childcare and elderly care.



More women access their right to inheritance and property

Equal opportunities to inheritance and property are crucial to women's economic empowerment. This year, KWN has made progress toward increasing the number of women as property owners. More women and men know their rights and are informed about how to register property as a single owner or jointly.

KWN continued with the awareness-raising campaign "My house, my right", to raise the awareness about the importance of registering the property by women; and to support women in registering their property. The initiative resulted successful, as proved by the fact that 6,088 citizens in five municipalities (3150 women and 2938 men) met by KWN members during the campaign are more aware about the importance of registration of property by women.

Through this initiative, KWN members have gained knowledge and skills that will allow them to continue the support of women in registering the property in the future. In addition, 153 women have started registration of property.

Furthermore, during the time period of this initiative, KWN advocated with the Gender Equality Office under the Office of the Prime Minister of the Republic to push the Government to extend the time limit of the Administrative Instruction on Joint Registration of Property, which ended in early 2017.

This Administrative Instruction proved to be an affirmative measure in encouraging couples to register their property as joint property. KWN advocacy, obviously, was a contributing factor to accelerate the approval of the extension of the present Administrative Instruction for an additional year.

More citizens aware of women's right to inheritance and property

KWN members also took the initiative to raise awareness among 707 men and women. Supported by KWN through KWF, Norma informed 300 men and women from the municipality of Prizren, Ferizaj, Podujeva and Gracanica, while Handikos Mitrovica informed 100 disabled women and men. Lulishtja informed 220 women and men from the villages of Gllogovicë, Hajkobillë, Marevc, Dabishec, Dumosh and Keqekollë, of the municipalities of Prishtina and Podujevo, whereas Women Association "ATO" informed 87 women and men from the municipality of Vushtrri and its villages.

More women take steps to secure their right to inheritance and property

Supported by KWF and Handikos Mitrovica, one woman registered her property during the implementation of the project, while 4 other are in process of registration of property with the support of Women Association "ATO".



Relevant officials held more accountable to respecting women's right to inheritanceand property

Supported by KWN, Norma submitted a request to the Kosovo Judicial Council and the Notary Chamber to review the number of closed cases of property and inheritance in 4 basic courts, namely in Prizren, Ferizaj, Podujeva and Gracanica. Based on these reviews, data, problems and difficulties faced by women during the realization of their property rights were analyzed. Based on data collected during the above-mentioned review, the Report of findings was drafted, which was presented at the round table.

Partners in Kosovo have monitored six cases at the Registry Offices, of which 3 belonged to the Municipality of Drenas and other 3 to the Municipality of Mamusha with the aim of advancement of the women's rights to property, based on the obligations that derive from the applicable legislation, and improvement and strengthening of institutional capacities for the provision of higher quality services.

Women's access to family resources improved

The KWN has not directly worked on this issue during 2017, except for the activities already mentioned.



The extent to which EU policies and programs involve a gender perspective improved and oversight from a gender perspective related to EU policies and programs in Kosovo improved

The KWN has continued to provide technical support to the EU delegation, Ministry of European Integration, Agency on Gender Equality at the Prime Minister's Office, Officers for Gender Equality for inclusion of the gender perspective in Pre-Accession Instrument (IPA) programs in Kosovo, including the planning and implementation phases. As part of this, the KWN has also supported the development of the Gender Action Plan of the EU delegation for the period 2016-2020 in Kosovo.

Meanwhile, through the support of the KCK, the KWN has given a contribution from the gender perspective to the progress reports, the European Reform Agenda, the political dialogues and the National Programme for the Implementation of the Stabilization and Association Agreement (NPISAA) in Kosovo. Also, in November, the KWN published the document of policies *Kosovo's Progress in approximation of its laws with the EU laws on gender equality.*

The document is drafted by two well-known European lawyers and experts of gender equality, Sylvia Cleff le Divellec and Katahrina Miller, and it assesses the approximation of Kosovo laws with the *Acquis*- on Gender Equality of EU.

The document identifies shortcomings and provides recommendations for a better harmonization of the Kosovo laws with the *Acquis*.

In addition, KWN in close consultation with its members, WCSOs, partners and other interested stakeholders, has drafted the *Strategy for Integrating Gender Perspective in Kosovo's EU Accession*. **ICSOs**.**

process. This strategy will lead the future advocacy of the KWN and its partners towards the advancement of gender perspective in the process of accession to EU. Whilst the Strategy is focused on Kosovo, it also deals with a regional perspective, by taking into consideration the similarities with the situation in WB Countries and the EU approach to theis accession processes, as well as their potential regarding the joint advocacy, in cooperation with partner WCSOs in the region.

For the next year is planned the publication of three documents with respect to the change of modalities of EU funds available for women's organizations, inclusion of a gender perspective in the financial and development documents of the Pre-Accession Assistance (IPA) Instrument and the assessment of implementation of the Gender Action Plan 2016-2020 (GAP II) of the Council of the European Union.


