

Introduction

Our Vision

The Kosovo Women's Network (KWN) has a vision of a Kosovo in which women and men are equal and have equal opportunities for education, employment, political participation, health care and a life without violence.

Construction of the State of the

Our Mission

The Network's Mission is to support, protect and promote the rights and interests of women and girls throughout Kosovo, regardless of their political and religious beliefs, age, level of education, sexual orientation, and abilities. KWN fulfils its mission through exchange of experiences and information, partnerships and networking, research, advocacy, and services.

Our Strategy

To accomplish its vision and mission, KWN has a <u>Strategy for 2023-2026</u> that guides KWN's work. The Strategy was drafted in 2022 with input from KWN member organisations, the Board of Directors,

partners, and other stakeholders. The Strategy has four programs: I) Improving Gender Equality through the Rule of Law; II) A Life Free from Gender-based Violence; III) Women's Economic Empowerment; and IV) Education that Transforms Gender Norms. It has two cross-cutting aims: Strengthening the Feminist Movement and a Gender-responsive Approach to Climate Change.

About the KWN Annual Report

Each year KWN reports to its members, partners, and friends regarding the progress made towards achieving its strategic objectives. This report contains information from I January to 31 December 2023. This report is divided in six sections based on KWN's four programs, related long-term objectives, and two cross-cutting aims:

• Improving Gender Equality through the Rule of Law

This report presents the achievements and results in each of these programs and crosscutting aims in 2023. Overall, KWN has implemented approximately 70% of its Strategy. The report also contains information about KWN's budget, supporters, Board of Directors, Advisory Board, staff, interns, volunteers, members, and grant beneficiaries.



Improving Gender Equality through the Rule of Law

The first program in the KWN Strategy 2023-2026 focuses on Rule of Law. Generally, this implies that all laws in Kosovo are relevant in terms of guaranteeing the human rights of women and girls as rights guaranteed by law. The program's **overall long-term objective** is to improve gender equality through the rule of law. Some progress was made towards this objective as KWN influenced 10 laws and policies in 2023, totalling 267 since KWN began counting in 2012. KWN's progress on this Program was supported by the EU, Sweden, the Kvinna till Kvinna Foundation, Austrian Development Agency (ADA), UN Women, and the Canada Fund for Local Innitiative.

This section details progress made towards the specific objectives and immediate results (in boldface), as shown by indicators from KWN's Monitoring and Evaluation database.

Increased and improved women's participation in politics and decisionmaking at local and central levels according to the Law on Gender Equality (50%) and UNSCR 1325

KWN has continued its efforts to increase the political engagement of women in decision-making processes, including women with disabilities and minority women. Through initiatives supported by the Kosovo Women's Fund (KWF), in 2023, 41 women interested in political processes attended trainings and mentoring through KWN members' initiatives. Meanwhile, KWN supported an additional eight.

women to engage in decision-making related to amending the labour law, totalling 49 diverse women in 2023.

KWN advocated locally and internationally for implementation of United Nations Security Council Resolution (UNSCR) 1325 on Women, Peace, and Security (2000) by sending a letter in June 2023 to the European External Action Service, European Parliament, European Commission, European Union (EU) Office in Kosovo, and other EU officials related to the EU's measures towards Kosovo and their impact on women's participation in decision-making processes. KWN requested urgent inclusion of women in the political dialogue between Kosovo and Serbia both in the negotiation teams and via consultations at the local level, as per UNSCR 1325. KWN emphasised the same requests during an advocacy trip to Germany and to the EU in Brussels, both supported by the Kvinna till Kvinna Foundation, elaborated below.

Enhanced the capacities of women in politics to advocate for women's priorities

KWN Executive Director Igballe Rogova continued mentoring member organisations, women politicians at local and central levels, KWN members, and other groups across Kosovo, empowering women in politics and diverse women in voicing their priorities towards gender equality. She promoted their initiatives, supported their advocacy, and assisted them in overcoming various challenges. KWN informed women about the EU Accession process and ways in which they can engage in it.

Increased public officials' awareness of the importance of harmonising the Law on Gender Equality with election laws

KWN continued advocating for aligning Kosovo legislation with the Law on Gender Equality. Together with the Office of the President of Kosovo, KWN, its members, and partners established a working group on gender equality that lobbied for amending the Law on General Elections to include a quota for equal participation (50%) of women and men candidates in elections as per the Law on Gender Equality's definition of equality. KWN also requested that the 2023 European Commission's (EC) Kosovo Report reiterate this recommendation for aligning the Law on General Elections with the Law on Gender Equality to the Kosovo government. Although the amended Law did not include a 50% quota, it does require some funding to be set aside for women candidates' political campaigns, following KWN's, among others', advocacy on women's lack of funding and equal representation in local and general elections.

Increased officials' awareness of the need to improve attention to gender equality in laws, policies, and programs

Progress towards this objective was made in 2023, as KWN sent recommendations to officials for improving attention to gender equality in **ten** different laws, policies, and programs, including:

- I. Draft Civil Code of Kosovo (remains a draft)
- 2. Draft Law on Gender Based Violence and Violence against Women (adopted)
- 3. Draft Law on Social Services (remains a draft)

- 4. Draft Law on Reproductive Health (remains a draft)
- 5. Draft Law on Early Education (adopted)
- 6. Economic Reform Program 2023-2025 (adopted)
- 7. Draft Digital Agenda 2030 (adopted)
- 8. Draft Law on 2024 Budget of Kosovo (adopted)
- 9. Draft Rule of Law Strategy (adopted)
- Monitoring Report on the implementation of the Kosovo Program for Gender Equality 2020-2024 (published by the Agency for Gender Equality)

Increased the awareness of government officials, the EU, UN, and other actors about the importance of engaging diverse women in peace processes with Serbia and addressing women's priorities in these processes, according to UNSCR 1325In 2023, Kosovo had a fragile political situation with several attacks occurring in northern Kosovo, EU-imposed measures towards Kosovo, and collaboration among Serb and Kosovar women's rights civil society organisations (WCSOs) affected amid political tensions and threats made against Serb WCSOs and activists. KWN consistently advocated the importance of engaging diverse women in peace processes and safeguarding the security of women activists. Towards this objective, KWN sent 19 advocacy letters and attended nine meetings to increase officials' awareness on the need to include more women in peace processes, including:

• Letter sent to Monika Gajowy in the EU Office in Kosovo, Political Section, to inform the EC Kosovo Report 2023, as a joint input of KWN members (March 2023)

- Input sent to the government related to the Stabilisation and Association Agreement (SAA) Subcommittee on Justice, Freedom, and Security (however, the meeting between the government and the EU was canceled, due to the EU imposed measures in June 2023).
- Thirteen letters were sent to representatives of the EC, European External Action Service, EU Special Representative for Belgrade-Pristina Dialogue Miroslav Lajčák, High Representative of the EU for Foreign Affairs and Security Policy Josep Borrell Fontelles, the European Parliament, and UN Women regarding the potential gender equality-related impacts of the EU imposed measures towards Kosovo. The letter was sent in July 2023.
- During six advocacy meetings in Berlin, supported by the Kvinna till Kvinna Foundation, KWN advocated for women's increased and improved involvement in peacemaking processes during meetings with Special Representative for the Western Balkans Manuel Sarrazin, Member of Parliament (MP) Adis Ahmetovic's team, and Frédéric Jörgens from the Ministry of Foreign Affairs. KWN also sent two advocacy letters as a follow up to meetings to Frédéric Jörgens and Christine Toetzke, Director for EU and multilateral development policy at the Federal Ministry for Economic Cooperation and Development (BMZ).
- During the annual EU Advocacy Week in Brussels organised by the Kvinna till Kvinna Foundation in November 2023, KWN consistently emphasisesd the need to implement the EU's Women, Peace, and Security Agenda, including advocating for including more women in political dialogue and ensuring and

the security of Kosovar and Serb women peace activists, KWN met the following officials, raising theses issues:

Two follow up advocacy letters were sent to Vivien Savoye the Rule of Law Desk Officer, and Djordje Bojovic, Western Balkans Advisor in the Office of ME) and European Parliament Rapporteur for Kosovo Viola von Cramon-Taubadel.



KWN has just initiated work on this area and will more on it in 2024.

Improve implementation of the EU GAP III and a gender perspective in the EU Accession process

KWN contributed towards implementing the EU Gender Action Plan (GAP III), Country Level Implementation Plan (CLIP) for Kosovo, through its <u>Monitoring Report: Gender Mainstreaming of the EU</u> <u>Accession Process</u>, which used GAP III indicators to measure the extent to which the Kosovar government and the EU Office in Kosovo implemented GAP III. KWN also made progress towards the following results.

Further increased the awareness and capacities of EU officials on how to implement GAP III, especially by including, as well as financially and politically supporting diverse women's rights CSOs

KWN made progress towards this result, as KWN increased 15 EU officials' awareness on how to implement EU GAP III, particularly by financially and politically supporting diverse WCSOs. KWN used various advocacy channels to increase their knowledge. This included Christine Toetzke, Director for EU and multilateral development policy at BMZ, where KWN and other Kvinna till Kvinna partners discussed

sustainable funding modalities for supporting WCSOs towards achieving social change. They also met Irene Ceccanti, Administrative and Policy Assistant at the EU Direcotrate General for Neighbourhood and Enlargment Negotiations (DG NEAR), and the Coordinator on Gender Equality and the Rights of the Child, sharing findings from <u>KWN's 2022 Monitoring Report on Gender Mainstreaming the EU Accession</u> <u>Process</u> on how GAP III couled be further implemented. Via 14 advocacy letters (totaling 194 since 2018) KWN also increased awareness on how to implement EU GAP III among officials at the EU Office in Kosovo, DG NEAR, EEAS, and EUSR.

Improved inclusion of a gender perspective in documents related to Kosovo's EU Accession and their implementation

KWN continously monitored the drafting of new public policies and legislation related to Kosovo's EU Accession, providing input to inform them from a gender perspective. However, most policies on which KWN provided comments remained drafts due to continuous delays by the government and/or Assembly of Kosovo (e.g., the Civil Code of Kosovo, Law on Labour, Law on Reproductive Health). In 2023, KWN counted three documents adopted related to EU Accession that included significant input from KWN: the Economic Reform Program 2023-2025 adopted approximately 75% of KWN's suggestions; the EC Kosovo Report 2023 adopted approximately 75% of KWN's comments; and the EC Kosovo Report 2023 included input from KWN, as detailed in the <u>Commentary on the EC Kosovo Report 2023</u>.

Improved the knowledge and capacities of EU officials, National Gender Equality

Mechanisms (NGEMs), and line ministries regarding integration of a gender perspective in documents related to EU Accession and to the importance of including CSOs in the EU Accession process

KWN has excellent communication channels with EU officials in Kosovo and Brussels, NGEMs, and the Office of the Prime Minister towards improving attenditon to gender equality in documents related to EU Accession. KWN met with 18 EU and governmental officials, as well as 5 NGEMs to discuss the importance of including WCSOs in the EU Accession process, focusing on political dialogue and security issues. KWN also sent 14 letters to officials on these matters. With NGEMs, KWN coordinated to wwrite *Gender Equality: At the Center of IT and Beyond: A Gender Analysis of Digitalisation in Kosovo*. KWN interviewed five gender equality officers and gathered their input, using these occasions to discuss ways in which NGEMs can be more involved in policy-making processes, including EU Accession processes. Currently, the Office of the Prime Minister coordinates communication and consultation processes between the governmet and civil society, including related to EU Accession. More efforts are needed to ensure coordination *within* line ministries towards increasing a gender perspective in different sectors.

Improved and increased the participation of CSOs in the EU Accession process, including monitoring this process from a gender perspective

KWN continued involving member organisations and partner CSOs in the EU Accession process, including monitoring this process from a gender perspective. This included collecting diverse CSOs' input_______

for the EC Kosovo Report 2023, government and EU consultations on SAA structures, and government consultations with civil society on the European Reform Agenda. In 2023, 10 CSOs collaborated with KWN in monitoring EU Accession processes, including an intersectional approach to this monitoring. The CSOs engaged included organisations supporting women in rural areas, with disabilities, of different ages, and of diverse ethnicities:

Improve the institutionalisation of gender-responsive budgeting in Kosovo, towards implementing the Law on Gender Equality

Towards achieving this objective, KWN continued advocacy towards instutionalising gender-responsive budgeting via annual budget recommendations sent to the government of Kosovo, Ministry of Finance, Labour, and Transfers, parliament, and municipalities. KWN emphasised the importance of instituitonalising gender-responsive budgeting by adding it into the legal framework on public finance during meetings with officials from Kosovo's local and national institutions, as well as international actors. KWN worked towards achieving the following immediate results related to this objective in 2023.

he Bridge and Service

Fiscal policies are more informed by gender analysis

In 2023, KWN provided recommendations towards

improving the gender perspective in the Law on Budget for 2024 and the Law on Local Finance.

Increased the capacities of CSOs to advocate for implementing gender-responsive budgeting

As part of the Gender Budget Watchdog Network, a network of organisations in the Western Balkans and Moldova, KWN worked to increase the capacities of CSOs to advocate for implementing genderresponsive budgeting through training and mentoring. KWN facilitated the Network's strategic planning process, which included identifying ways to strengthen the network and CSOs within it. KWN also supported CSOs to conduct Organisational and Advocacy Capacity Assessments, including conducting these for KWN, EkoKos Women, and Mitrovica Women's Association for Human Rights, towards identifying ways to strengthen advocacy capacities as part of gender-responsive budgeting efforts.

Increased officials' knowledge about gender-responsive budgeting

In 2023, KWN advocated to five key officials towards furthering their knowledge and understanding of gender-responsive budgeting, the importance of institutionalising it, and steps they needed to take to this end, including the President of Kosovo, Prime Minister, Minister of Finance, Labour, and Transfers, Deputy Minister of Finance, Labour, and Transfers, and the Minister of Justice.

Increased the participation of women in public consultations on the budget

KWN engaged 11 member organisations in mobilising citizens, particularly women, to participate in public consultations on the 2024 Budget.

Improve CSOs' participation in gender mainstreaming climate change financing

Towards improving CSOs' participation in gender mainstreaming climate change financing, KWN provided grants through which EkoKos Women and Mitrovica Women's Association for Human Rights are conducting research. KWN also supported the development of new methodologies for gender mainstreaming climate financing as part of the Gender Budget Watchdog Network as a first step towards supportin CSOs in this work.

Improve women's and men's access to and realising their rights to health services, based on the legal framework

Following years of insufficient financing related to this objective, KWN was able to initiate efforts towards realising this objective via KWN member organisations with support from the Kosovo Women's Fund (KWF), financed by the Austrian Development Agency. Several organizations took significant actions to address barriers to women's access to quality healthcare, while a few initiatives were taken by relevant institutions to address issues that hinder women's rights to quality healthcare. As these efforts have just begun, actions have not yet been taken by institutions to address the complaints filed. Yet, KWN can report several immediate results thanks to the efforts of KWN members, described below.

Increased women and girls' awareness of their right to healthcare and the importance of accessing healthcare

Through KWF, 556 individuals (552 women and four men) were inspired to advocate for their right to quality health services in 2023. KWN member organisations held information sessions and helped women and men realise their rights to health services, based on the legal framework. As a result, 20 women decided to file complaints with the relevant authorities regarding rights violations.

In total, via KWF initiatives, KWN members support documentation of 20 rights abuses, which were reported to authorities.

More public officials, women, girls, and men informed of women's right to healthcare and violations of their rights

KWN and its members, supported by KWF, held 22 meetings with public officials aimed at addressing and promoting women's rights to receive quality healthcare. Through KWF supported initiatives, 552 women and four men were educated about their healthcare rights, while 20 individuals chose to take further action by filing complaints, with ten cases documented by Handikos Mitrovica, five by CECD Friends, and another five by the Women's Alliance for Integration.

The beneficiaries expressed gratitude for the information shared and appreciated having a platform to voice their experiences of healthcare rights violations. During a workshop hosted by NGO Drugeza,

one participant remarked, "I wish I had known that we could complain to someone about these cruel words that the doctors are telling us."

NGO EcoKosWomen facilitated workshops where Roma, Ashkali, and Egyptian women shared their reactions, stating, "This project has empowered us and provided us with valuable knowledge. We now feel prepared to advocate for better healthcare services and have gained confidence in asserting our health rights." They further expressed their readiness to submit complaints regarding violations of their right to health services, knowing where to direct them for appropriate action.

A Life Free from Gender-Based Violence

The overall objective of this program is to improve the response to gender-based violence, towards its reduction. KWN has made modest progress towards achieving this overall objective though several challenges remain. This section outlines progress towards the specific objectives and expected immediate results (in boldface). Progress was supported by ADA, the EU, Sweden, UN Women, and the Canada Fund for Local Initiative.

Improved the quality and implementation of the legal framework for gender-based violence, including the institutional response to assisting victims of violence

Towards this specific objective, in 2022 KWN submitted detailed comments on the Draft Law on Protection against Domestic Violence and Gender-Based Violence, the Law on Social Housing, and the Law on Social and Family Services. Since these laws were not in line with the Istanbul Convention, KWN submitted comments towards aligning them with the Istanbul Convention and clarifying legal responsibilities to improve their implementation. Building on these and other prior efforts, in 2023 KWN participated in a workshop, providing more detailed comments on the Law on Prevention and Protection against Domestic Violence, Violence against Women, and Gender-Based Violence. This Law was adopted in October 2023, addressing several of KWN's recommendations. For example, the Law, better defines

the roles and responsibilities of Coordinating Mechanisms against Gender-based Violence, based on KWN's recommendations. Moreover, while the prior Law previously only addressed domestic violence, the new Law now covers all forms of gender-based violence and violence against women in accordance with the Istanbul Convention. Additionally, following KWN, its members (particularly shelters), and others' advocacy, the Law on Budget for 2023 finally allocated sufficient funds for covering the costs of shelters for women and children suffering gender-based violence. Meanwhile, KWN plans to assess the quality of institutional response to gender-based violence in 2024. In 2023, KWN undertook efforts towards the following immediate results.

Improved the accountability of institutions responsible for assisting gender-based violence cases

Through legal assistance, KWN has continued its support for women seeking justice for violence, contributing to improving implementation of the relevant legal framework and the accountability of institutions responsible by monitoring their work. In 2023, KWN supported 28 cases, informing women about their rights, institutions where they can seek assistance, and referring them to lawyers for legal aid. Women were referred to relevant justice institutions, as well as to psychologists in shelters for counseling. Additionally, KWN monitored 17 cases of gender-based violence in courts, towards holding institutions accountable in their treatment of cases.

Furthered knowledge regarding the extent to which the legal framework related to gender-based violence has been implemented, as well as the awareness and prevalence of domestic violence

Building on training provided in 2022 for officials from various institutions and members of Coordination Mechanisms against Domestic Violence, in 2023 KWN provided further training on the State Protocol for the Treatment of Sexual Violence Cases, their responsibilities, and case management for sexual violence cases. Trainings were held in Podujevo, Lipjan, Deçan, Obiliq, Kaçanik, and Novo Brdo. These were organised in collaboration with KWN member organizations, namely shelters operating in these cities. In total, 92 representatives of various institutions working to address gender-based violence were trained.

Additionally, KWN engaged in 16 advocacy meetings in 2023, including via regular participation in the National Interministierial Coordination Group on gender-based violence. Advocacy meetings related to KWN recommendations in the report *From Laws to Action.* Additionally, with support from KWF, shelters advocated for establishing coordination mechanisms in some municipalities, including in Serbian majority municipalities like Shterpce, Ranillug, and Kllokot.

Improved awareness of people about the legal framework and their rights

Exhibitions. press releases. television appearances, and protests all aimed to inform more people about their rights. The travelling interactive street exhibition "Do Not Hide Violence Behind Walls" continued, informing approximately 5,880 individuals (3,991 women and 1,880 men) about the legal framework and their rights, since 2019. In 2023, the exhibition was organised in six municipalities: Gjilan, Lipjan, Mitrovica, Podujevo, Skenderaj, and Vushtrri, reaching approximately 300 individuals (202 women and 98 men). In 2023, KWN also had nine press releases

related to cases of femicide, sexual harassment, sexual assaults, and violence. Further, KWN condemned the discriminatory and sexist language used by institutional representatives against women and girls. KWN organised online media campaigns to inform citizens about the State Portocol for Treatment of Sexual Violence, which reached 58,800. On 28 December, KWN advocated for shelters to be funded by the Ministry of Finance, Labour, and Transfers in January and February 2024 so that they would not face funding shortages as in prior years, which had placed women and children sheltered there at risk. Following KWN's advocacy, the Ministry allocated an Emergency Fund for shelters and other organisations providing crucial social and family services for the January-February period. On 8 March, KWN joined the annual protest of International Women's Day, "We March, We Don't Celebrate: for a Life without Violence against Girls and Women". Citizens raised their voices to protest against injustices faced by women, including femicide. Also, in August 2023, KWN supported the protest and closely followed the court's verdict for Dardan Krivaça regarding the murder of Marigona Osmani.

Continued engagement of KWN, KWN members, and CSOs in furthering the implementation of the legal framework for addressing gender-based violence

In December 2023, KWN together with shelters for victims of domestic violence and the organisation Protecting Victims Preventing Trafficking (PVPT) sent an advocacy letter to the Prime Minister of Kosovo, the Mistry of Justice, and the Ministry of Finance. Labour and Transfers regarding funding for shelters. As in previous years, the state failed to address the issue of finacing shelters during the first months of the year. KWN with shelters requested that the government address this issue. In response, the government established an emergency fund for shelters and other social service providers to ensure funding for this period. KWN and shelters also worked to further implementation of the legal framework throughout 2023, in coordination with municipal coordination mechanisms.

and quality of services of shelters and other service providers

Improved performance and quality of services of shelters and other service providers working with victims of gender-based violence, especially rehabilitation and reintegration services

As part of the continued training for Coordination Mechanisms against Domestic Violence, KWN provided training for shelters and other service providers, familiarising them with the State Protocol for the Treatment of Sexual Violence Cases and their institutional responsibilities. In total, in 2023, KWN trained 92 representatives (34 men and 58 women) in Decan, Ferizaj, Junik, Kaqanik, Lipjan, Novobrdo, Obilic, Podujeve, and Prishtina municipalities. Four participants were Serbian. With KWN's support, shelters have started meeting monthly with Coordination Mechanisms against Domestic Violence to address jointly specific cases treated by shelters. KWN also held two workshops for 39 shelter representatives related to preventing professional burnout, stress management, and "Improving Services for Survivors of Violence". Participants discussed laws, the Istanbul Convention, case management, staff workload, insufficient finances to cover their expenses, and providing quality services.

Continue providing recommendations to improve laws and policies

KWN continued monitoring the adoption of laws in line with the Istanbul Convention and submitted detailed comments for amending laws, including on the Draft Law on Protection against Domestic Violence and Gender-Based Violence, the Law on Social Housing, and the Law on Social and Family Services. Related to addressing gender-based violence via the legal framework, KWN also submitted comments on the Rule of Law Strategy, Law on Budget for 2024, and Monitoring Report of the Kosovo



Program for Gender Equality 2020-2025. KWN participated in a workshop organised by the Human Rights Commission for amending the Draft Law on Protection against Domestic Violence and Gender-Based Violence, where KWN activists pushed for aligning this Law with the Istanbul Convention. As noted, several of KWN's recommendations were adopted.

Women's Economic Empowerment

The overall objective of this program is that women and men have equal economic opportunities at home and in the public sphere. KWN has made progress towards achieving this objective, as shown by progress on the following specific objectives and expected results in bold.

Improved conditions for women's participation in the labour force

KWN continued its efforts to harmonise Kosovo's legal framework with the EU Acquis on gender equality, especially related to labour legislation. As a result of KWN's advocacy, three laws and policies have been improved related to labour and women's economic empowerment, including the Economic Reform (ERP) 2023-2025, the Law on Prevention and Protection against Domestic Violence, Violence against Women, and Gender-Based Violence that attends to labour for women have have suffered violence, and the Digital Agenda.

Increased the awareness of institutions and other actors regarding the need to harmonise labour legislation with the EU legal framework, among other needed improvements to the legal framework

KWN undertook several initiatives to increase awareness among institutions and other actors, including by using the public consultation platform to comment on primary and secondary legislation in relation to

labour regulations. In addition to the aforementioned laws and policies that now include an improved gender perspective following KWN's advocacy, KWN also sent input to the EU Office in Kosovo to inform the Social Policy and Employment chapter of the EC Kosovo Report 2023.

KWN also met key actors involved in labour policies, facilitating discussions between the Women's Economic Forum, an informal coalition of leading think tanks and CSOs¹, and the Office of the Prime Minister on gaps and inconsistencies between Kosovo's labour law and EU standards. Through advocacy KWN and the Forum emphasised the need for amending the law to further gender equality in labour.

Further, KWN utilised advocacy letters to raise awareness and push for policy changes. These letters articulated challenges faced by women in the labour market due to existing legal barriers and provided recommendations for reform. By directly engaging with policymakers and decision-makers through these advocacy letters, KWN and its partners drew attention to the urgency of harmonising labour legislation with the EU legal framework, especially related to maternity, paternity, and parental leave as per the EU Work-Life Balance Directive.

Institutions and key actors are more aware of the extent of gender-based discrimination in labour in Kosovo and ways to address it

KWN continued raising awareness about the prevalence of gender-based discrimination in labour via approximately 18 advocacy efforts towards the EU and government. During meetings with EU officials, KWN requested an improved gender perspective in the EC Kosovo Report 2023 related to labour rights violations, as well as raised this issue during the SAA Sub-committee meeting on Social Policy and Employment. KWN advocated for improved address of gender-based discrimination by harmonising existing laws and improving mechanisms for reporting it and sexual harassment at work. KWN emphasised this issue in preliminary findings of its gender analysis of digitalisation shared with EU and government stakeholders.

Improve access to justice in cases of gender-based discrimination in labour and violations of women's rights at work

While cases were referred in prior years and KWN has sought financial support (unsuccessfully) to support further cases, no such cases were referred in 2023.

Increase awareness about the informal economy and how to address it using a gender-responsive approach

KWN began research for its gender analysis of the informal economy, supported by the EU and Sweden with a contribution from UN FAO through a synergy initiative. The first of its kind in Kosovo and much of the region, it aimed to provide the government with concrete recommendations to inform the forthcoming Strategy to address informality, ensuring a gender-responsive "do no harm" approach. The analysis will inform future advocacy, increasing awareness about the informal economy and how to address it.

More officials are aware of the need for more preschools and childcare centers, care for the elderly, and care for the disabled, especially in rural areas

KWN continued its advocacy efforts towards improving the availability of childcare, elderly care, and care for persons with disabilities via at least seven advocacy initiatives in 2023. This included during two meetings held in Brussels with EU officials, during the Subcommittee meeting on Information and Social Policy, related to recommendations for the EC Kosovo Report for 2023, and within the framework of the ERP for 2023-2025. KWN also advocated for the Law on Budget to allocate resources for supporting childcare and elderly care. In voicing concern about the government's postponement of the draft Law on Labour, KWN emphasised the importance of child and elderly care provisions within the broader legislative framework.

Increased women's access to inheritance and ownership through legal reforms, awareness, and legal aid

With support from KWN via KWF, KWN member organisation Norma initiated and sent a joint letter to relevant authorities, advocating for women and girls' inheritance and property rights to be adequately safeguarded via the new, still to be approved, Civil Code. Also, supported by KWF, Medica Kosova informed 25 survivors of domestic violence about legal procedures for accessing property and other legal rights. Then, Medica Kosova helped six surivors take concrete actions to register their property in their own names or in the names of both spouses.

Improved awareness of officials on how to improve the living conditions of rural women and women with disabilities

Using an intersectional approach in its advocacy, KWN submitted comments on at least four laws and policies towards improving the lives of rural women and women with disabilities, including the ERP for 2023-2025, the draft Law on Family and Social Services, the draft Law on Reproductive Health, and the Law on Budget for 2024.

More officials of international funding institutions are informed about gender responsive policies

KWN advocated to at least 16 officials in international funding institutions about the need and strategies for more gender-responsive funding policies. KWN advocated for long-term, flexible financing for WCSOs to support their strategic work.

Gender Transformative Education

The overall objective of this program is improving access to quality education that challenges existing gender norms and power relations. KWN has taken steps towards achieving this overall objective, as shown by progress on the following specific objectives and expected results, supported by ADA and Sweden.

Improve textbooks and the way teachers teach curricula towards gender-transformative, feminist education

Towards this specific objective planned for 2024-2025, KWN in collaboration with its members made progress towards the following expected results.

Recommendations exist and are sent to relevant actors for improving teaching by teachers and curricula

In 2023, KWN made progress towards improving curricula and teaching methods from a gender perspective. With KWF support, five KWN members conducted research involving observation in various municipalities to understand the extent to which education has a gender-transformative approach, seeking to identify ways to change traditional gender roles and stereotypes. Following agreements with the Ministry of Education, Science, Technology, and Innovation (MESTI) and local institutions, activists observed school premises, classrooms, and teachers' teaching of selected subjects. Using a set

methodology, the research aimed to understand the extent to which school environments (building infrastructure), knowledge of teachers, administrators, and staff, learning materials, pedagogy, and student participation contribute to gender-transformative learning environments.

Together with five KWN member organisations, KWN observed 10 schools in the municipalities of Pristina, Vushtrri, Peja, Gjakova, and Drenas. In total, 43 course lessons were observed related to biology, civic education, physical education, and the Albanian language. Additionally, researchers conducted 14 interviews with teachers and a focus group with 10 teachers teaching psychology, sociology, English language, history, and civic education. The Resource Center for Blind Persons in Peja also engaged in observation.

After completing the research, KWN members presented preliminary research findings via four reports to relevant municipal actors and explored effective strategies towards more gender-transformative education. During advocacy meetings, KWN members recommended educational institutions integrate specialised subjects into curricula, directly addressing gender stereotypes from an early age. Additionally, they emphasised the importance of training teachers on gender stereotypes, gender-based discrimination, violence, and the rights of girls and women. They also advocated for updating textbooks and teaching materials to include content that promotes gender equality and actively challenges prevailing stereotypes and biases. Moreover, they recommended organising training for teachers and school staff to enhance their abilities in identifying, managing, and reporting cases of gender-based violence, as well as offering adequate support to victims. Additionally, the importance of monitoring and evaluating the impact of interventions and policies related to sexual education and gender equality was underscored.

Such evaluations are vital for ensuring the effectiveness of these initiatives and making informed adjustments where necessary.

KWN has begun consolidating and analysing information collected by member organisations, towards developing a policy brief with recommendations. It will be shared with MESTI to facilitate continued collaborative efforts towards more gender-transformative education.

Institutions and teachers are more responsible for transforming gender norms while teaching sexual education in schools

Building on recommendations derived from the research, KWN in close collaboration with MESTI plans to initiate targeted training for teachers from schools engaged in the research in 2024. It will seek to enhance the capabilities of educators, empowering them to create gender-transformative learning environments.

More girls, women, boys, and men aware of gender norms and feminism and reached through KWN PR materials

Towards increasing the awareness of girls, women, boys, and men, KWN regularly promoted its work and the work of its members on the KWN website, Facebook page, Twitter, Instagram, and in its monthly electronic newsletter: *Kosovar Women's Voice*. In 2023, KWN had 149 media appearances. KWN increased its Facebook followers from 24,805 in 2022 to 26,936 in 2023. On Twitter the number of followers increased from 1,544 to 1,552, and on Instagram from 3,201 to 3,287, respectively.

Crosscutting Aim: Strengthening the Feminist Movement

This crosscutting overall objective aims to strengthen the existing feminist movement in Kosovo, the region, and beyond, via all KWN programs. KWN has made progress towards this overall objective, as the KWN Strategy guiding efforts towards expanding the feminist movement work exists, KWN members remained active through different activities, including three KWN members' meetings held in 2023; and I I women and men supported KWN in 2023. Meanwhile, 2,595 women Human Rights Defenders have received support from KWN via KWF. Progress has been made towards this long-term aim related to the following specific objectives and expected results in bold headings below.

Increase solidarity and wellbeing among women's organisations and activists

KWN continued its interethnic partnerships in the region through the Coalition for Addressing Genderbased Discrimination in Labor in the Western Balkans (WB); partnership with organisations to gendermainstream the EU Accession process through EQUAPRO; the Gender Budget Watchdog Network (GBWN) in the WB and Republic of Moldova, seeking to institutionalise gender-responsive budgeting; a network of organisations researching funding for gender equality and women's rights; the Network against

Gender-based Violence against Women and Girls in the WB, involving WCSOs from five countries in improving rehabilitation and reintegration services for survivors of gender-based violence; the European Women's Lobby as a supporting member; and KWN joined the Women against Violence in Europe (WAVE) network in in 2023. Moreover, KWN undertook at least seven joint advocacy initiatives in collaboration with other WCSOs outside the Network. These included: 1) preparatory meetings with other WCSOs in the region prior to Berlin Advocacy Week supported by the Kvinna till Kvinna Foundation; 2) the joint Berlin Advocacy Week; 3) EU Advocacy Week joint meetings, supported by the Kvinna till Kvinna till Kvinna Foundation; 4) preparing joint input for the EC Kosovo Report; 5) providing joint input on the draft Civil Code of Kosovo; 6) sending a joint reaction letter regarding the draft Law on Labour; 7) organising a joint meeting with the Prime Minister of Kosovo Mr. Kurti, Minister of Finance, Labour, and Transfers Mr. Murati, Deputy Minister of Finance, Labour, and Transfers Mr. Dobruna, and other government representatives to discuss concerns about the draft Law on Labour and the implementation of gender-responsivem budgeting in Kosovo.

More women, men, girls, and boys involved in the feminist movement

In 2023, KWN engaged six young women and men volunteers. This gave them the opportunity to become more knowledgeable in organising, researching, advocating, integrating attention to gender equality into human rights advocacy, monitoring court cases, about gender-based violence, and about other issues that women in Kosovo face. Through engaging more young people, KWN seeks to further strengthen the feminist movement in Kosovo.

Improve the capacity of KWN members, towards their sustainability

Following the 2023 awarded grants, KWN conducted the initial Organizational Assessment and Capacity Analysis (OACA) with all KWF recipients to evaluate changes in their capacities. Tailored Capacity Development Plans were created and implemented with KWN's support, focusing on areas such as public relations, financial management, and advocacy. Workshops were also organized to enhance skills in advocacy, project proposal writing, fundraising, and public speaking. For the closed initiatives, at the end KWN conducted the second OACA assessment to measure progress which has increased substantially.

Increased the capacities of KWN staff

KWN staff attended at least 16 different capacity-development activities related to human resources, climate change, the Green Agenda, proposed finance reforms by the World Bank, working conditions, state funding for SOS helplines, the New Gen(d)eration, and digital accounting.

Improve the funding climate for women's rights organisations

KWN sought to make progress towards this midterm specific objective, to be measured at the end of KWN's current strategic period, through the following expected results.

Improved implementation of KWN's Resource Mobilisation Strategy

Fundraising through alternative forms is vital for diversifying resources and improving the financial sustainability of CSOs. KWN has established a strategy towards mobilising diverse resources and took some steps towards implementing it. For example, KWN continued coordination with other CSOs towards improving the legal and institutional framework for philanthropy in Kosovo. As part of the Philanthropy Forum, KWN participated in several meetings towards overcoming obstacles in fundraising for CSOs in Kosovo. On 27 April, KWN representatives participated in a meeting that brought together 14 participants from various sectors to discuss problems that CSOs face with banking services and opportunities for collecting funds online. Participants agreed to cooperate in identifying solutions to these obstacles.

KWN continued participating in meetings organised by the Government's Cooperation Council with Civil Society towards coordinating and monitoring implementation of the Government Strategy for Cooperation with Civil Society 2019-2023. KWN representatives participated in working groups organised by CiviKos on "Improving the institutional framework for financing the sustainability of CSO programs and projects in the public interest". KWN collaborated with other CSOs to advocate on the importance of the government establishing a sufficient, transparent, and permanent budget line for civil society support, towards the sustainability and resilience of WCSOs in the future.

In May and June, KWN organised ten mentoring sessions for KWF grantees towards enhancing their capacities and resilience, particularly in the aftermath of the COVID-19 pandemic. Supported by EU, the mentoring sessions were conducted with shelters in Ferizaj, Gjilan, Mitrovica, Prizren, Gjakova, and Peja,

as well as with three other WCSOs and Center for Education and Community Development Friends. KWN staff introduced grant recipients to the KWN Resource Mobilization Strategy and helped them identify new avenues for diversifying their resources, mapping community resources, securing additional funding, and enhancing their sustainability and resilience.

On 16 March, KWN staff also delivered training in Prizren on the topic "Resource Diversification and Fundraising", organised by the Kosovo Civil Society Foundation. This basic training aimed to increase the capacities of local CSOs and activists on diverse fundraising models towards sustaining their work. Approximately 13 participants (five women and eight men of diverse ethnicities and rural/urban areas) from different CSOs in Prizren attended. Participants' diverse areas of focus included furthering gender equality, education, supporting marginalised groups, environmental protection, energy efficiency, youth, and reconciliation. Participants gained new knowledge on mapping potential donors and identifying different fundraising models. All of these efforts contributed to progress towards implementing the KWN Resource Mobilisation Strategy.

Improved knowledge and understanding among relevant funders regarding the types of support that diverse WCSOs need

In close collaboration with partner organisations in the region, KWN informed approximately ten representatives of various funding organisations about diverse WCSOs' funding needs, including during advocacy towards the German government in the context of their feminist foreign policy, as well as in advocacy towards the EU, all supported by the Kvinnat till Kvinna Foundation.

Crosscutting Aim: Environmental Protection

The overall objective of this crosscurring aim is to improve the extent to which gender, including the different needs and interests of diverse women and men, are reflected in environmental policy and urban planning, in line with the EU GAP III. KWN made some initial progress towards this objective in 2023 by providing input related to the EU Instrument for Pre-Accession (IPA) III Action Plan on Climate Change and Environment. KWN staff also attended training and furthered their knowledge to prepare for a gender analysis related to gender-responsive budgeting and climate change, planned for 2024. Based on analysis, KWN plans to undertake evidence-based advocacy towards more gender-responsive laws and policies related to climate change.


